AN ORDINANCE DECLARING IT TO BE UNLAWFUL FOR ANY PERSON OR PERSONS TO HITCH, STAND OR PLACE ANY HORSE, OR TEAM OF HORSES, OR ANY MULE OR TEAM OF MULES, OR ANY COW OR KINE ON COLUMBIA STREET, A PART OF THE COLUMBIA RIVER HIGHWAY, ALSO KNOWN AS COLUMBIA STREET, BETWEEN THE EAST LINE OF KIBLING STREET, EXTENDED, AND THE EASTERLY LINE OF HALSEY STREET, EXTENDED, WHERE SAID HALSEY STREET ENTERS THE SAID COLUMBIA RIVER HIGHWAY ALSO KNOWN AS COLUMBIA STREET, IN THE TOWN OF TROUTDALE, IN MULTHOMAH COUNTY, OREGON, FOR A PERIOD LONGER THAN FIVE (5) MINUTES IN ANY ONE PLACE IN SAID AREA.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE TOWN OF TROUTDALE:

Section 1. It is hereby declared to be unlawful, and against the peace, dignity and safety of the people of the Town of Troutdale, in Multnomah County, Oregon, for any person or persons to tie, stand or place any horse or team of horses, mult or team of mulem, or any cow or kine on Columbia Street, a part of the Columbia River Highway, also known as Columbia Street, between the East line of Kibling Street, extended, and the Easterly line of Halsey Street, extended, where said Halsey Street enters the said Columbia River Highway, also known as Columbia Street, in said Town of Troutdale, in Multnomah County, Oregon, for a period longer than five (5) minutes in any one place in said area.

Section 2. Any person violating any provision of this Ordinance, shall, upon conviction thereof, before the City Recorder, in the Recorder's Court, in the Town of Troutdale, be punished by a fine of not lose than Five (\$5.00) Dollars nor more than Ten (\$10.00) Dollars, or by imprisonment in the City Jail for not more than one (1) day, or by both such fine and imprisonment at the discretion of the Court.

Section 3. If any fine levied under authority of this Ordinance is not paid to the Recorder by the Defendant, such Defendant shall serve one (1) day in the City Jail for each Two (\$2.00) Dollars of the fine not paid.

SECTION 4. In as much as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the residents and inhabitants of the Town of Troutdale an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect from and after its passage by the Common Council, and the signing of same by the Mayor.
