

ORDINANCE NO. 95

RELATING TO ABANDONED VEHICLES, AND REPEALING ORDINANCE NO. 81.

Section 1. For the purposes of the Ordinance the following terms, contained in the Oregon Revised Statutes as amended by Oregon Laws of 1967, shall have the following meanings:

1. "Department of State Police" or "sheriff" means Town Marshall.
2. "County road" includes "City street".
3. "outside the corporate limits of incorporated cities or towns" means "inside the corporate limits of the Town of Troutdale".
4. "state property" includes "Town of Troutdale property".
5. "county" where used other than in sub-paragraph (2) herein means "Town of Troutdale".
6. "department" where used alone means "Department of Motor Vehicles".

Section 2. Except as revised by Section 1 hereof, Oregon Revised Statutes, as amended or adopted by Oregon Laws of 1967, Chapter 484, Sections 483.380, 483.382, 483.384, 483.386, 483.388, 483.390, 483.392, 483.394, 483.395 and 483.396 are hereby adopted by reference. This adoption includes new sections of the Code adopted by said Chapter 484.

Section 3. Ordinance No. 81, adopted May 12, 1964, is hereby repealed.

Section 4. That whereas it is necessary for the immediate preservation of the peace, health and safety of the Town of Troutdale and of the credit of said Town that this ordinance take effect immediately; therefore, an emergency is declared to exist, and this ordinance shall be in full force and effect from and after its passage by the Council and approval by the Mayor.

Ordinance No. 95

An Ordinance proposing and submitting to the legal voters and qualified electors of the Town of Troutdale, Oregon, for their adoption or a rejection at a special town election an amendment to the Charter of said Town by adding Section 43, authorizing and providing for the issuance and sale of Town of Troutdale, Oregon, sewage and disposal bonds in a sum not exceeding \$215,000.00 for the purpose of procuring funds with which to acquire, construct and equip, either within or without the corporate limits of the Town of Troutdale, Oregon, in whole or in part, sewage treatment facilities, a stabilization ponds or lagoons, sanitary sewers, intercepting sewers, out-fall sewers, force mains, pumping stations, with all appurtenances necessary usual or convenient, for the collection and treatment and disposal of sewage, and providing for the payment of principal and interest upon said bonds from service charges, connection charges, rents and other funds as may be received from the operation of said sewer system and sewage disposal plant, and providing for a levy of a special tax to pay principal and interest upon said bonds, providing for the holding of a special election to submit said proposed amendment to the legal voters of said town, and also permitting the legal voters and qualified electors of said town to vote upon any other municipal measure or question which may then be pending by initiative or referendum proceedings or otherwise for the adoption or rejection of the same by the legal voters of said town; repealing all ordinances or parts of ordinances in conflict herewith and declaring an emergency.

TOWN CHARTER OF TROUTDALE, OREGON, REMAINS AS FOLLOWS:

SECTION 1. That the following proposed amendment to the Charter of said Town is hereby proposed for submission to the legal voters and qualified electors of said Town for their adoption or rejection at a special town election to be called and held in said Town on the 10th day of October, 1917.

CHARTER AMENDMENT SUBMITTED TO THE VOTERS BY THE COUNCIL.

AN ACT

To amend an act entitled, "Repealing a charter for the Town of Troutdale, Multnomah County, Oregon, and repealing any and all former charters or amendments thereto of the Town of Troutdale, Multnomah County, Oregon," adopted by the people of the Town of Troutdale, Oregon, at an election held August 21, 1942, by adding thereto a new section to be numbered Section 43, and providing for the issuance and sale of the Town of Troutdale, Oregon, sewage disposal bonds in a sum not to exceed \$215,000.00.

BE IT ENACTED BY THE PEOPLE OF THE TOWN OF TROUTDALE, OREGON,

That an act entitled, "Repealing a Charter for the Town of Troutdale, Multnomah County, Oregon, and repealing any and all former Charters or amendments thereto of the Town of Troutdale, Multnomah County, Oregon," adopted by the people of the Town of Troutdale, Oregon, at an election held August 21, 1942, be and the same is hereby amended by adding thereto a new section to be numbered Section 43 to read as follows:

SECTION 43. For the purpose of procuring funds with which to acquire, construct and equip, either within or without the corporate limits of the Town of Troutdale, Oregon, in whole or in part, sewage treatment facilities, stabilization ponds or lagoons, sanitary sewers, intercepting sewers, out-fall sewers, force mains, pumping stations, with all appurtenances necessary, usual or convenient, and to acquire real and personal property appurtenant thereto or connected therewith, for which funds have been or will be ordered paid out of the Sewage Disposal Bond Fund by the Council, the Council of the Town of Troutdale, Oregon, is hereby authorized and empowered to issue and sell general obligation bonds of the Town of Troutdale, Oregon in a sum not to exceed \$215,000.00; said bonds to bear date and mature as determined by the Council, but shall mature within, but not to exceed forty years from date of issuance thereof, and shall bear interest not exceeding six percent per annum, payable annually or semi-annually, as determined by the Council or as limited by applicable state law, each of said bonds to be a general obligation of the Town of Troutdale, Oregon, and to be known as Town of Troutdale, Oregon, Sewage Disposal Bonds.

The Council shall each year, at the time of making the annual tax levy for city purposes, include in such levy a sum sufficient to be used jointly with service charges, connection charges, rents and other funds as may be received from the operation of said sewer system and sewage disposal plant, to pay the interest due on the outstanding bonds of said issue and to retire the principal thereof at maturity, which funds when collected and turned over to the City Treasurer shall be by him transferred and kept in a separate fund known as the Sewage Disposal Bond Fund. The Council is authorized to pledge all or any part of the net revenues received from the operation of said sewer system and sewage disposal plant.

All acts or parts of acts, whether enacted by the Legislative Assembly or the State of Oregon or adopted by vote of the people of the Town of Troutdale, Oregon, in conflict of this act are expressly repealed.

SECTION 2. That this Ordinance for the proposed Charter Amendment submitted to the voters by the Council be filed with the Recorder of the Town of Troutdale, Oregon, for submission to the legal voters of said Town for their rejection or approval to be voted upon at a special election to be held as herein provided.

SECTION 3. That the Council does hereby and herein call and make necessary provisions for the holding of a special election which shall be and hereby is called to be held on the 10th day of October 1967, between the legal voting hours on said day, to-wit: between the hours of eight o'clock in the forenoon and until eight o'clock in the afternoon, and the said time to be and the same hereby is designated as the time for holding said special election, and the Town Hall of the Town of Troutdale, Oregon, is hereby designated as the polling place therefor, and the following named persons are hereby designated and appointed as and for the judges and clerks of said election, to-wit:

LONG TITLE: An Act to amend the Charter of the Town of Troutdale, Oregon, adopted by the people at a special election held August 24, 1962, by adding Section 43 providing for the issuance and sale of Town of Troutdale, Oregon, Sewer Disposal Bonds in a sum not exceeding \$215,000.00 providing funds to pay for the acquisition or construction of a sewer system and sewage disposal plant with appurtenances within or without the corporate limits of the Town of Troutdale, Oregon, and providing revenue and a levy of a tax to pay principal and interest on said bonds.

SECTION 5. That the Recorder be and she hereby is instructed to give a ten days' notice of said election by written or printed notices posted in three public places within the Town of Troutdale, Oregon, which notices shall contain a reasonable statement as to the above proposed Charter Amendment and the place designated in the Town for holding such election and the names of the judges and clerks appointed to conduct said election.

SECTION 6. That the legal voters and qualified electors of the Town of Troutdale, Oregon, be and they are hereby permitted and allowed to vote upon any other municipal measures, Charter amendments, Ordinances or questions which may then be pending, regularly proposed by initiative petition or referred by referendum petition or otherwise submitted to the people for the adoption or rejection of the same by the legal voters of said town.

SECTION 7. That all ordinances or parts of ordinances in conflict or inconsistent herewith are hereby repealed.

SECTION 8. Whereas, the Town of Troutdale, Oregon, is without sewer system or sewage disposal plant, and that some of the sewage of said Town is now deposited in the Sandy River and other water tributaries thereto, and on account thereof the said water of the Sandy River and tributaries are polluted and thereby an unsanitary condition exists in the Town of Troutdale, Oregon, and adjacent territory, involving the peace, health and safety of the Town and the inhabitants thereof; and

Whereas, the Sanitary Authority of the State of Oregon has insisted upon the immediate construction of said sewer system and sewage disposal plant; and

Whereas, the Town of Troutdale, Oregon, is seeking to obtain State and Federal assistance in the construction of sewage treatment works, and it is necessary that construction commence as soon as possible, in order that the Town may qualify to receive said Federal and State Aid; and

It appearing to the Council and the Council finds that it is necessary for the immediate preservation of the peace, health and safety of said Town and the inhabitants thereof, that this ordinance go into immediate effect, an emergency is hereby declared to exist and this ordinance shall go into immediate effect upon its adoption by the Council and approval by the Mayor.
