ORDINANCE NO. 118

AN ORDINANCE PROPOSING AND SUBMITTING TO THE LEGAL VOTERS AND THE QUALIFIED ELECTORS OF THE TOWN OF TROUTDALE, OREGON, FOR THEIR ADOPTION OR REJECTION AT THE GENERAL ELECTION TO BE HELD IN 1968, AN AMENDMENT TO THE CHARTER OF SAID TOWN TO CHANGE THE NAME SO THAT IN ALL PLACES IN SAID CHARTER THE NAME OF THIS MUNICIPALITY SHALL BE THE CITY OF TROUTDALE; REPEALING ALL PARTS OF ORDINANCES IN CONFLICT HEREWITH AND DECLARING AN EMERGENCY. Be MUNICIPALITY OF TROUTDALE, OR COMMENT THE PROPER OF THE TOWN OF TROUTDALE, OR COMMENT.

Section 1. That the following proposed mendment to the Charter of soid term is barely proposed for submission to the legal voters and gu lifted electors of a id term for their adoption or rejection at the regular term election to be held on the 5th day of November, 1963.

To amend an act entitled, "Enacting a charter for the Town of Troutdale, Multnomah County, Oregon, and repealing any and all former Charters or amendments thereto of the Town of Troutdale, Multnomah County, Oregon, adopted by the people of the Town of Troutdale, Oregon, at an election held August 24, 1942, by adding thereto a new section to be numbered Section 44, to change the name of the municipal corporation of the Town of Troutdale, Oregon, to the City of Troutdale, Oregon. COMMON COUNCIL

BE IT ENACTED BY THE THE TOWN OF TROUTDALE, OREGON

That an act entitled, "Enacting a charter for the Town of Troutdale, Multhomah County, Oregon, and repealing any and all former charters adopted by the people of the Town of Troutdale, Oregon, at an election held August 24, 1942, be and the same is hereby amended by adding thereto a new section to be numbered Section 44 to read as follows:

SECTION 44. NAME. The name of the Municipal corporation of the Town of Troutdale is hereby changed to the City of Troutdale. That at every place within the Charter of the City of Troutdale where reference is made to the Town of Troutdale the said Charter shall be amended to read the City of Troutdale.

All acts or parts of acts, adopted by vote of the people of the Town of Troutdale, Oregon, in conflict with this act are expressly repealed.

SECTION 2. That this ordinance for the proposed Charter amendment submitted to the voters by the Council be filed with the Recorder of the Town of Troutdale, Oregon, for submission to the legal voters of said Town for their rejection or approval, to be voted on at the general election to be held on November 5, 1968.

SECTION 3. Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the people of the Town of Troutdale in the judgment of the Common Council, now, therefore, an emergency is hereby declared to exist and this Ordinance shall be in force and effect from and after its passage by the Common Council of the Town of Troutdale and its algning by the Mayor.
