AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF TROUTDALE.

Whereas, there has been submitted to the City of Troutdale written proposal for annexation to the City by more than two-thirds of the landowners who also own more than two-thirds of the land in the contiguous territory described below which real property therein represents more than two-thirds of the assessed value of all real property in the contiguous territory to be annexed; and

Whereas, Ordinance No. <u>123</u> was passed, initiating the annexation of said territory, calling a hearing and directing that notice be given thereon, and since the hearing was held at which time all objections or remonstrances of the City of Troutdale and since that body feels that annexation is to the best interest of the City and of the contiguous territory; now therefore,

THE PEOPLE OF THE CITY OF TROUTDALE DO ORDAIN:

SECTION 1. <u>Annexation Area.</u> The following described contiguous territory is hereby proclaimed to be annexed to the City of Troutdale:

LEGAL DESCRIPTION FOR ANNEXATION TO CITY OF TROUTDALE

A tract of land situated in Sections 25, 26, 35, and 36, Township 1 North, Range 3 East of the Willamette Meridian, and in Section 1, Township 1 South, Range 3 East of the Willamette Meridian, County of Multnomah and State of Oregon, more particularly described as follows:

SECTION 2. <u>Record.</u> The City Recorder shall submit to the Secretary of the State of Oregon (1) a copy of this ordinance, (2) a copy of the Statement of consent of the landowners in the territory annexed, and (3) a copy of the Ordinance No. <u>123</u> dispensing with an election in the City on the question of annexation. The City Recorder shall also send a description by metes and bounds of leagal subdivisions, of the new boundaries of the City within ten (10) days of the effective date of annexation to the Multnomah County Assessor and the Multnomah County Clerk.
