

ORDINANCE NO. 128.

AN ORDINANCE PRESCRIBING THE METHODS AND PROCEDURES FOR MAKING PUBLIC IMPROVEMENTS IN THE CITY OF TROUTDALE, FOR LEVYING AND COLLECTING SPECIAL ASSESSMENTS THEREFOR, AND FOR THE CREATION AND ENFORCEMENT OF ASSESSMENT LIENS: REPEALING ORDINANCE 29; RATIFYING PREVIOUS COUNCIL ACTION; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF TROUTDALE.

SECTION 1. The action of the City Council of December 10, 1968 adopting the Resolution on file herein of said date, relating to a local improvement program consisting of the construction of a Sanitary Sewer System throughout the City of Troutdale is hereby ratified and confirmed.

SECTION 2. Ordinance 29 is hereby repealed.

SECTION 3. Whereas the minimum procedural requirements for assessment for City improvements are set forth in the Oregon Revised Statute and that the procedures and powers described therein are adequate with respect to local improvements, the statutes hereafter set forth are adopted by reference to the extent that they are appropriate or applicable as setting forth the minimum standards to be adhered to and the general procedure to be followed by the City of Troutdale in assessment for local improvements, re-assessment for local improvements and methods of enforcing liens and collecting assessments. 
