

AN ORDINANCE RE-ENACTING AND ENFORCING ORDINANCE NO. 201,
CURING DEFECTS IN THE ENACTMENT THEREOF, AND DECLARING AN EMERGENCY.

WHEREAS, ordinance No. 201 provides a uniform system of house numbering and designation of streets, provides for penalties, provides for an effective date of compliance, repeals ordinance No. 53, and declares an emergency.

WHEREAS, the following street names are in violation of ordinance No. 201; now therefore, be it resolved that these street names are to be corrected as follows:

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF TROUTDALE:

SECTION 1. Relating to N. E. Boyer Court.

WHEREAS, "N. E. Boyer Court" is located in the Southwest section of the Troutdale street grid and whereas said street aligns with "S. W. Edgefield Place" on the street grid, "N. E. Boyer Court" shall be known hereafter as S. W. Edgefield Court.

SECTION 2. Relating to streets in Sandee Palisades Subdivision.

S. E. 31st. Court shall be known as S. E. 30th Court;
S. E. 30th. Street shall be known as S. E. 29th Street;
S. E. 30th. Court shall be known as S. E. 29th Court;
S. E. 29th. Court shall be known as S. E. 28th Court;
S. E. 28th. Court shall be known as S. E. 27th. Court;
S. E. 27th. Street shall be known as S. E. 26th Street;
S. E. 27th. Court shall be known as S. E. 25th Court.

SECTION 3. Relating to "Douglass Way"

Douglass Way shall be known as S. W. 15th Street.

SECTION 4. Relating to streets in Kiku Heights Subdivision.

That portion of S. E. 20th Street running east and west shall be known as S. E. 19th Street;
That portion of S. E. 20th Street running north and south shall be known as S. E. 19th Place;
That portion of S. E. 19th Street running east and west shall be known as S. E. 18th Street;
That portion of S. E. 19th Street running north and south shall be known as S. E. 18th Place.

SECTION 5. EMERGENCY CLAUSE.

Inasmuch as this ordinance is necessary for the immediate preservation of public health, peace and safety of the people of the City of Troutdale and in the judgement of the Common Council, now therefore, an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Troutdale and its signing by the Mayor.
