

AN ORDINANCE RE-ENACTING AND ENFORCING ORDINANCE NO. 201, CURING DEFECTS IN THE ENACTMENT THEREOF, AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 201 provides a uniform system of house numbering and designation of streets, provides for penalties, provides for an effective date of compliance, repeals Ordinance No. 53, and declares an emergency; and

WHEREAS, the following street names are in violation of Ordinance No. 201.

NOW, THEREFORE, BE IT RESOLVED that these street names are to be corrected as follows:

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF TROUTDALE THAT:

SECTION 1. Relating to S.W. 26th Circle and S.W. 26th Way in Fleur-de-Lis Subdivision.

S.W. 26th Circle shall be known hereafter as S.W. 27th Circle;
S.W. 26th Way shall be known hereafter as S.W. 27th Way.

SECTION 2. Relating to S.W. Peneton Lane in Anton Ridge Subdivision.

That portion of S.W. Peneton Lane running north and south shall be known hereafter as S.W. McGinnis Avenue; that portion of S.W. Peneton Lane running east and west shall be known hereafter as S.W. 13th Place.

SECTION 3. Relating to S.W. Larssen Avenue in Woodale Subdivision.

S.W. Larssen Avenue shall be known hereafter as S.W. Larsson Avenue.

SECTION 4. Relating to that portion of the street in Fraley Heights Subdivision, Phase III, running north and south.

That portion of the street shall be known hereafter as S.W. Kings Byway.

SECTION 5. Relating to S.E. Stott Circle in Valerie Terrace Subdivision.

S.E. Stott Circle shall be known hereafter as S.E. Stott Court.

SECTION 6. Emergency Clause.

Inasmuch as this ordinance is necessary for the immediate preservation of public health, peace and safety of the people of the City of Troutdale in the judgement of the Common Council, now therefore, an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Troutdale and its signing by the Mayor.
