# ORDINANCE NO. 384-0

AN ORDINANCE ESTABLISHING AND IMPOSING WASTE WATER USER CHARGES AND A WASTE WATER SYSTEMS DEVELOPMENT AND IMPROVEMENT CHARGE, AND REPEALING ORDINANCE NO. 317

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF TROUTDALE:

#### SECTION 1. SHORT TITLE

This Ordinance shall be known as the WASTE WATER RATES ORDINANCE.

## SECTION 2. DEFINITIONS

Unless the context specifically indicates otherwise, the meaning of terms used in this Ordinance shall be as those defined in the Waste Water Regulations Ordinance No. 280.

#### SECTION 3. WASTE WATER USER FEES AND CHARGES

The Waste Water User Fee for each equivalent residential unit, as defined by the Waste Water Regulations Ordinance, shall be set at \$7.15 per month from July 1, 1982 to December 31, 1982, and shall be set at \$8.25 per month effective January 1, 1983.

### SECTION 4. WASTE WATER SYSTEM DEVELOPMENT CHARGE

The Waste Water Development Charge (SDC) shall be payable for each equivalent residential unit, and shall be the sum of a "base prepayment" and a "balance payment", to become effective on the dates and in the amounts shown below unless changed by Council Ordinance:

July 1, 1981 - June 30, 1982	\$725.00	\$625.00
July 1, 1982 - June 30, 1983	775.00	725.00
July 1, 1983 - June 30, 1984	825.00	825.00
July 1, 1984 - Until revised	875.00	925.00

### SECTION 5. SEVERABILITY CLAUSE

If any clause, sentence, paragraph, section, or portion of this Ordinance for any reason shall be adjudged invalid by a court of competent jurisdictions, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance, but shall be confined in its operation to the clause, sentence, paragraph, section, or portion of this Ordinance directly involved in the controversy in which the judgment is rendered.

# SECTION 6. REPEALING A PREVIOUS ORDINANCE

Ordinance No. 317, passed March 11, 1980, is hereby repealed.
