

AN ORDINANCE VACATING A PORTION OF 6TH STREET

WHEREAS, Pursuant to ORS 271.120 a hearing was held on May 8, 1984 at which the Common Council made the following findings:


1. That section of 6th Street between the east line of S.E. Harlow Street and the center line of S.E. Kibling Street has for a number of years been closed to the public and used as part of the playground at Troutdale Elementary School. This area is depicted in Exhibit 'A'.
2. Other areas that were previously City street rights-of-ways and have been used as part of the school ground were similarly vacated by the City through vacation procedures in 1915 and 1973.
3. The City Council initiated proceedings authorized by ORS 271.130, and made such vacation without petition of property owners.
4. "Notice of Street Vacation" has been posted in manner prescribed by ORS 271.110 twenty-eight (28) days before the hearing.
5. Reynolds School District, owners of property abutting street area to be vacated, have consented to the vacation.
6. Owners of a majority of the area affected, as defined by ORS 271.080, have not objected to the vacation.
7. The portion of 6th Street to be vacated shall continue to be used for School purposes.
8. The public's interest will not be prejudiced by the vacation.

NOW, THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF TROUTDALE THAT:

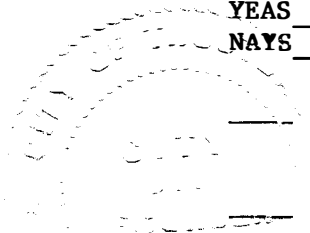
