

ORDINANCE NO. 489-0

AN ORDINANCE AMENDING THE PUBLIC SAFETY CODE.

WHEREAS, the present Public Safety Code contains references to certain statutes or practices defined by Oregon Revised Statutes; and

WHEREAS, certain Oregon Revised Statutes have been amended or renumbered; and

WHEREAS, the City wishes to revise and update all ordinances prior to codification.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF TROUTDALE THAT:

P.S.C. 7.10.025 IS AMENDED TO READ:

Duties of the City Administrator: The City Administrator or his designate shall exercise the following duties:

A. Implement the ordinances, resolution and motions of the council and his own orders by installing, maintaining, removing and altering traffic control devices. Such installation shall be based on the standards contained i the Oregon Manual on Uniform Traffic Control Devices for Streets and Highways.

B. Duties exercised by the City Administrator or his designate shall be reported to the council at the regular meeting immediately following their implementation and the council may reject or modify such action. This reporting requirement may be dispensed with when the council so orders.

C. Establish, remove or alter the following classes of traffic controls:

1. Crosswalks, safety zones and traffic lanes.
2. Intersection, channelization and areas where drivers of vehicles shall not make right, left, or U-turns, and the time when the prohibition applies.
3. Parking areas and time limitations, including the form of permissible parking (e.g. parallel or diagonal).
4. Traffic control signals.
5. Loading zones and stops for vehicles.

D. Issue oversize or overweight vehicle permits.

E. Designate certain streets as bridle paths and prohibit horses and animals on other streets.

F. Temporarily block or close streets.

G. Establish bicycle lanes and paths and traffic control for such facilities.

P.S.C. 7.10.220 IS AMENDED TO READ:

Registered Owner Presumption. Owner is defined as set forth in ORS 8701.370.

Towing and Storage Liens.

A. A person who, at the request of the police officer, takes a vehicle into custody under the provisions of this chapter, shall have a lien on the vehicle for the just and reasonable towing and storage charges, may retain possession of the vehicle until the charges are paid, and may have the vehicle sold at public auction to satisfy the lien. The lien that attaches to the vehicle shall be a possessory chattel lien in accordance with ORS 87.152 and shall be foreclosed in the manner provided in ORS 87.152 to 87.212. If the appraised value of the vehicle is \$750 or less, the vehicle shall be disposed of in the manner provided in ORS 819.220(1).

B. If the vehicle is taken into custody under the provisions of this chapter and held by request, the vehicle shall be disposed of in the manner provided in ORS 819.130 to 819.210.

P.S.C. 7.20.030 IS AMENDED TO READ:



In addition to provisions of this chapter regulating animals, the following statutes shall apply in the City of Troutdale and shall be enforced by the director in the same manner as though set forth fully in this chapter, and by this reference, they are incorporated within this chapter.

P.S.C. 7.20.050 IS AMENDED TO READ:


