

ORDINANCE NO. 496-0

AN ORDINANCE CHANGING OFFICIAL STREET NAMES AND AMENDING THE OFFICIAL STREET MAP OF THE CITY OF TROUTDALE

WHEREAS, Multnomah County and ORS 227.120 require that all official street name changes be submitted in an ordinance format, and

WHEREAS, final plats of subdivisions have been submitted to the City for amendment to include historic names, and

WHEREAS, street name changes to conform to the Official Street Map have been recommended by the Building Official and Fire District No. 10, and

WHEREAS, inconsistencies exist between Multnomah County Division of Assessment and Taxation Records and City maps.

NOW, THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF TROUTDALE THAT:




