TAX LOT 33, SECTION 35, T1N, R3E, WM FROM R-5 SINGLE-FAMILY RESIDENTIAL TO A-2 APARTMENT RESIDENTIAL;

TAX LOT 19, SECTION 36, T1N, R3E, WM FROM R-5 SINGLE-FAMILY TO A-2 APARTMENT RESIDENTIAL TO A-2 (APARTMENT RESIDENTIAL),
