## ORDINANCE NO. <u>579</u>-O

# ORDINANCE OF THE CITY OF TROUTDALE AMENDING AMUSEMENT DEVICE LICENSING REGULATIONS ORDINANCE NO. 49 [1957] -- TROUTDALE MUNICIPAL CODE TITLE 8, CHAPTER 5

WHEREAS, Chapter 5.08, AMUSEMENT AND VENDING MACHINES section of the Troutdale Municipal Code has not been addressed since 1957; and

WHEREAS, There have been numerous changes in the types of businesses and 'computerization' of amusement and vending machines; and

WHEREAS, The City of Troutdale has a need to address the multiple types of amusement devices and vending machines, for the efficient administration of such services, finds it necessary that amusement and vending machines be regulated and licensed; and

WHEREAS, that license fees are to be fixed and levied for the purpose of providing and financing such licensing and regulation.

# NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF TROUTDALE THAT:

Section 1. Chapter 5.08.030 License -- Required shall be amended to read as follows:

No person shall possess or receive any proceeds from a device subject to license in the city unless he has first obtained a license therefor as provided in this chapter.

Section 2. Chapter 5.08.050 Fee -- Amount be amended to read as follows:

The operator permit-license fee for each class of machine or device to be licensed and regulated under this Ordinance shall be set by Council Resolution. Section 3. Chapter 5.08.080 (A) be amended to read as follows:

5.08.080 License -- Application -- Form.

A. Licenses shall be issued to be effective on a calendar year basis. The license for a calendar year may be obtained on or before February 1st of the year of the license without penalty. No permit-license shall be issued for more than a year or for less than a year unless otherwise provided herein. Application for renewal of permitlicense shall be made prior to the expiration date stated on said license-permit or within fifteen days thereafter and shall be accompanied by the annual license-permit fee.

The full annual fee for each permit-license shall be paid at the time of making application with the following exceptions: such application is made and licensepermit is issued between April 1st and June 31st, three-fourths of the annual fee shall be charged; if between July 1st and September 31st, one-half of the annual fee shall be charged; and if between October 1st and December 31st, one-fourth of the annual fee shall be charged. The date upon which the license-permit is issued shall be controlling and such pro-rating shall refer only to the calendar year for which the permit-license is issued and not apply when advance application is made for a future permit-license.

The application shall be signed by the applicant or his agent, and shall set forth the following:

1. Device sought to be licensed, with make, model and serial number;

- 2. Name of applicant;
- 3. Name of agent making application, if any;
- 4. Location of device in the city.
