

RESOLUTION NO. 87-683-R

A RESOLUTION ACCEPTING A 3RD STREET RECONSTRUCTION PROJECT (CDBG NO. 86-05) FOR USE BY THE PUBLIC AND AUTHORIZING THE RELEASE OF ALL RETAINAGE AND TERMINATING AN INTERGOVERNMENTAL AGREEMENT.

WHEREAS, The City of Troutdale entered into an intergovernmental agreement with Multnomah County for the management and execution of the road reconstruction project named below; and

WHEREAS, The City has retained a portion of the contractor's funds for performance as set forth in the plans and specifications; and

WHEREAS, The road reconstruction project named below, and located within the City of Troutdale, has been completed; and

WHEREAS, The public improvement, as a condition of approval, has been constructed to the City of Troutdale's standards; and

WHEREAS, Multnomah County, the City of Troutdale and the project engineer have inspected the public improvements made reference herein and are recommending that the City accept these below named improvements.

NOW, THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL FOR THE CITY OF TROUTDALE THAT:

- 1) The City submit its reimbursement request to Multnomah County (CDBG Program).
- 2) The intergovernmental agreement between the City of Troutdale as affected by this project, and Multnomah County be declared complete and the agreement thereby terminated.
- 3) The City release any and all retainage to contractor(s) in a timely fashion as set forth and required by the project plans and specifications.
- 4) The City does hereby accept the following roadway public improvement project named below to be operated and maintained by the City of Troutdale for the general public from this day forward.

3RD STREET RECONSTRUCTION PROJECT
CDBG PROJECT NO. 86-05

Said project consists of the construction of approximately 540 lineal feet of City street including excavation, embankment, rock base, asphalt paving, curbs, sidewalks, storm drains, retaining walls and associated work.
