WHEREAS, the Municipal Court bail schedule was last adopted in 1985; and,


WHEREAS, substantial increases in administering the Court and State and County assessments have occurred,

The attached Bail Schedule dated September 25, 1989, is hereby adopted as established City Bail Schedule.


