## RESOLUTION NO. 828 - R

A RESOLUTION REGARDING THE FACTS AND PUBLIC HEARINGS INFORMATION, AND DECLARING THE CITY COUNCIL'S APPROVAL OF GARBAGE RATE INCREASES PURSUANT TO ORDINANCE NO. 309.

WHEREAS, Ege Sanitary Service, Inc., the sole franchisee for solid waste collection within Troutdale, has made application for an increase in their service rate schedule to pass-through to customers the increased cost of disposal together with the 3% Franchise Fee on the increase, and has provided the City with information to assist the Council in its determination of appropriate rates to be charged by franchisee; and

WHEREAS, Ege Sanitary service, Inc. continues to provide public service to the Troutdale community and has provided the Council with sufficient justification for granting this rate adjustment; and

WHEREAS, Ordinance No. 309 establishing a franchise agreement between Ege Sanitary Service, Inc. and the City of Troutdale prescribes rate changes to be accomplished by Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF TROUTDALE THAT:

Rates Effective July 1, 1990

I. Thirty-Two Gallon Can Maximum, One Stop Per Week:

(1) Single Family Residential and Commercial

One Can11.23 per monthTwo Cans21.46 per monthEach Additional Can8.87 per monthOnce a Month (on request)5.38 per month

(2) Multiple Dwellings and Trailer Courts - Four or more units with a single billing made to and paid by owner will be \$9.86 per can per month.

II. Roller Cart Maximum, One Stop Per Week (curbside). 15.60 per month

The collector may require a deposit of \$30 at the time a cart is initially placed. The deposit will be refunded upon return of the cart or at the expiration of five (5) years, whichever first occurs, providing the cart is maintained in good condition under the care, custody and control of the customer (reasonable wear and tear excepted). The collector may refuse carts to any customer where the use is not compatible with the cart. Cart service will not be provided for commercial customers. Carts shall not exceed the manufacturer's recommended maximum weight. If a customer's cart exceeds this weight, a reasonable extra charge may be assessed.

(2) <u>Compacted Material</u> - The rate for compacted material shall be double the rate for loose material if the customer furnishes the compactor. If the collector furnishes a compactor, the collector may charge such rental fee as is agreed upon by the customer and the collector. IV. Drop Box Rates: so a second of col

## (1) Loose Material

A. Steady or Monthly Accounts - When the collector furnishes the drop box, the rate shall be: \$3.50 per yard for a 20 yard box plus disposal fee, \$3.12 plus disposal fee for a 30 yard box, and \$2.66 plus disposal fee for a 40 yard box. Monthly rental shall be \$43.87, \$51.19 and \$58.50 respectively for the 20, 30 and 40 yard boxes.

B. Irregular or Non-Monthly Accounts - Rates for boxes delivered on an irregular or non-monthly basis shall be \$4.38 per yard plus disposal fee for a 20 yard box, \$3.73 per yard plus disposal fee for a 30 yard box, and \$3.62 per yard plus disposal fee for a 40 yard box. For boxes left on location for more than 48 hours, demurrage or rental charges shall be \$5.26 per day.

(2) <u>Compacted Material</u> - The rate shall be \$6.07 per yard plus the cost of disposal if customer furnishes the compactor. If collector furnishes the compactor, the collector may charge such rental fee as is agreed upon by the customer and collector.

(3) Mileage - In addition to the foregoing rates, collector shall be entitled to \$1.13 per mile for mileage in excess of 25 miles roundtrip from drop box to disposal site.
