

A RESOLUTION REGARDING THE FACTS AND PUBLIC HEARINGS INFORMATION, AND DECLARING THE CITY COUNCIL'S APPROVAL OF GARBAGE RATE INCREASES PURSUANT TO ORDINANCE NO.309

WHEREAS, Edwin O. Ege Sanitary Service, Inc., the sole franchisee for solid waste collection within Troutdale, has made application for an increase in their service rate schedule to compensate for operating costs, recycling costs and the costs of other programs the City of Troutdale is mandated to implement; and

WHEREAS, Edwin O. Ege Sanitary Service, Inc., continues to provide public service to the Troutdale community and has provided the council with sufficient justification for granting this rate adjustment; and

WHEREAS, Ordinance No. 309 establishing a franchise agreement between Edwin O. Ege, Inc. and the City of Troutdale prescribes rate changes to be accomplished by Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF TROUTDALE THAT:

The following rates attached as Exhibit "A" shall be effective on January 1, 1992.



EXHIBIT "A" TO RESOLUTION NO. 932-R
CITY OF TROUTDALE

Rates Effective January 1, 1992

I. Thirty-Two Gallon Can Maximum Monthly Rate:

(1) Single Family Residential and Commercial

One Can (One stop per week)	\$14.50 per month
Two Cans (One stop per week)	\$25.00 per month
Each Additional Can (One stop per week)	\$10.50 per month
Once a Month (on request per can)	\$ 6.50 per month

(2) Multiple Dwellings and Trailer Courts - Four or more units with a single with a single billing made to and paid by owner will be \$12.50 per can per month.

II. 15-20 Gallon Can Maximum Monthly Rate, One Stop Per Week

One Can	\$11.50 per month

III. Roller Cart Maximum, One Stop Per Week (curbside) \$19.00 per month

The collector may require a deposit of \$30 at the time a cart is initially placed. The deposit will be refunded upon return of the cart or at the expiration of five (5) years, whichever first occurs, providing the cart is maintained in good condition under the care, custody and control of the customer (reasonable wear and tear excepted). The collector may refuse carts to any customer where the use is not compatible with the cart. Cart service will not be provided for commercial customers. Carts shall not exceed the manufacturer's recommended maximum weight. If a customer's cart exceeds this weight, a reasonable extra charge may be assessed.

IV. Container Rates - First Stop Per Week, First Container

(1) Loose Material

2 Yards	\$115.85 per month
3 Yards	\$164.08 per month
4 Yards	\$211.39 per month

Additional pickups per week shall be at the following rates:

2 Yards	\$ 97.97 per month
3 Yards	\$139.20 per month
4 Yards	\$179.69 per month

(2) Compacted Material - The rate for compacted material shall be double the rate for loose material if the customer furnishes the compactor. If the collector furnishes a compactor, the collector may charge such rental fee as is agreed upon by the customer and the collector.

IV. Drop Box Rates:

(1) Loose Material

A. Steady or Monthly Accounts - When the collector furnishes the drop box, the rate shall be: \$4.38 per yard for a 20 yard box plus disposal fee, \$3.90 plus disposal fee for a 30 yard box, and \$3.26 plus disposal fee for a 40 yard box. Monthly rental shall be \$54.84, \$63.99 and \$73.13 respectively for the 20, 30 and 40 yard boxes.

B. Irregular or Non-Monthly Accounts - Rates for boxes delivered on an irregular or non-monthly basis shall be \$5.48 per yard plus disposal fee for a 20 yard box, \$4.66 per yard plus disposal fee for a 30 yard box, and \$4.53 per yard plus disposal fee for a 40 yard box. For boxes left on location for more than 48 hours, demurrage or rental charges shall be \$6.58 per day.

(2) Compacted Material - The rate shall be \$7.59 per yard plus the cost of the disposal if customer furnishes the compactor. If the collector furnishes the compactor, the collector may charge such rental fee as is agreed upon by the customer and collector.

(3) Mileage - In addition to the foregoing rates, collector shall be entitled to \$1.41 per mile for mileage in excess of 25 miles roundtrip from drop box to disposal site.
