

RESOLUTION NO. 991

A RESOLUTION ACCEPTING THE SEPTEMBER 15, 1992  
ELECTION RESULTS FROM THE DIRECTOR OF ELECTIONS,  
MULTNOMAH COUNTY, OREGON.

WHEREAS, Resolution No. 980-R called for a special election to submit to the voters the question of contracting a general obligation bonded indebtedness in the amount of \$600,000 to finance parks, including capital improvements and land acquisition, and to pay all costs incidental thereto; and

WHEREAS, the results of the election were certified by Vicki K. Ervin, Director of Elections, Multnomah County, Oregon; and

WHEREAS, the certification of the election results were received by Valerie J. Raglione, CMC, City Recorder of Troutdale, as outlined in ORS 255.295(1); and
