WHEREAS, the certification of the election results were received by George Martinez, City Recorder of Troutdale, as outlined in ORS 255.295 (1); and


WHEREAS, the results of the election are attached as Exhibit A.

Section 1. The results of the November 8, 1994 election, as certified, be accepted.


