**A RESOLUTION AUTHORIZING THE MAYOR TO SIGN AMENDMENT #1 TO MULTNOMAH COUNTY DEPARTMENT OF COMMUNITY AND FAMILY SERVICES CONTRACT #102246 FOR THE 4TH STREET IMPROVEMENTS, CDBG PROJECT #94-2**

**WHEREAS**, the City and Multnomah County have entered into a contract for FY 1994-95 Community Development Block Grant projects as authorized by Resolution No. 1116; and

**WHEREAS**, subsequent to the signing of said contract, the City experienced additional costs for retaining walls on a portion of SE 4th Street and requested additional CDBG funding from Multnomah County; and

**WHEREAS**, Multnomah County has authorized additional funding in the amount of \$30,912 and has prepared a proposed contract amendment to provide for this additional funding.


**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROUTDALE**
