

RESOLUTION NO. 1543

**A RESOLUTION ESTABLISHING SOLID WASTE COLLECTION FEES
AND RESCINDING RESOLUTION NO. 1407**

WHEREAS, Troutdale Municipal Code 12.10.060 provides that rates for solid waste collection may be changed periodically, by resolution; and

WHEREAS, the last comprehensive rate change was made by Resolution No. 1407 effective October 1st, 1998; and

WHEREAS, a consultant hired by the City has conducted a rate review and recommended certain changes to our rates; and

WHEREAS, those recommended changes were reviewed, modified as necessary, and are believed to be accurate.

TROUTDALE**


Section 1. The rates shown on the attached "Solid Waste Collection Fees" schedule are effective June 1, 2001.

Section 2. Resolution No. 1407 is rescinded effective May 31, 2001.



1. CURBSIDE RATES

a. Normal service (includes recycling) on a weekly pickup basis

3. DROP BOX RATES

a. Loose Material

b. Customer pays drop fee of \$19.15 whenever a box is delivered.

c. Customer also pays the actual disposal fee.

d. Mileage: The hauler may charge up to \$1.37 per mile for mileage in excess of 25 miles round trip from drop box disposal site

4. SHORT TERM AND ON CALL CONTAINER RATES

a. Short Term Container Service:

1. First Collection: 33% of Monthly Container Rate for the container size involved plus an initial container delivery fee of \$16.50 for the first container only.
2. Each Additional Collection: 33% of Monthly Container Rate for the container size involved.
3. Container Rent: Charge to a customer keeping a container longer than 5 working days (M-F) with no collection. Rent shall not exceed \$30.00 per container in a 30 day period.

2 Cubic Yards ~ \$2.00 a day

3 Cubic Yards ~ \$3.00 a day

4 Cubic Yards ~ \$4.00 a day

b. Short Term Yard Debris Container Service

1. First Collection: 25% of Monthly Container Rate for the container size involved plus an initial delivery fee of \$16.50 for the first container only.
2. Each Additional Collection: 25% of Monthly Container Rate for the container size involved.
3. Container Rent: Charge to a customer keeping a container longer than 5 working days (M-F) with no collection. Rent shall not exceed \$30.00 per container in a 30 day period.

2 Cubic Yards ~ \$2.00 a day

3 Cubic Yards ~ \$3.00 a day

4 Cubic Yards ~ \$4.00 a day

c. On call Container – when the container is full, the customer must call hauler for pickup

1. Per Collection: 33% of Monthly Container Rate for the container size involved.
2. Monthly Container Rent:

1 Cubic Yard ~ \$20.00

1.5 Cubic Yard ~ \$22.50

2 Cubic Yard ~ \$25.00

3 Cubic Yard ~ \$30.00

4 Cubic Yard ~ \$35.00

5. INFECTIOUS WASTE RATES

a. Boxes

1. 10 Gallon Box \$15.15

2. 20 Gallon Box \$17.30

3. 40 Gallon Box \$20.15

(Price includes box, liner, pick-up, and disposal)

b. Sharps Containers – (For needles, syringes, IV tubing, glass tubes, scalpel blades) – Household and occasional service

1. Four quart container \$11.15

2. Price includes container and disposal. Customer purchases container from hauler and brings to hauler's place of business when ready for disposal.

6. MISCELLANEOUS SERVICE FEES

a. Tire Disposal

Tires – off rim

\$2.50

Tires – on rim \$5.00

b. Appliance Disposal

Appliances \$15.00

Appliances with Freon \$30.00

c. Call Back Fee \$5.00

Fee may be charged if customer did not put can out by the prescribed time on scheduled collection day and still desires service prior to next scheduled collection day. Fee may be charged if the hauler must make an additional trip or must make a pickup on a non-pickup day.

d. Reinstatement Fee \$5.00

If customer account is discontinued due to non-payment after 30 days from due date, then a reinstatement fee may be charged if customer wishes to continue service.

e. Late Payment Service Charge

1.5 % per month. 18% per annum

Charges apply if payment not received within 30 days from date invoice mailed to customer.

f. Replacement of Lost Curby \$3.65

7. ADDITIONAL SERVICE

If a need for a type of service arises that is not now foreseen or specifically covered by this rate schedule, then the charge for such service shall be:

- a. Uniform and non-discriminatory between customers of a collector;*
- b. Commensurate with the rates generally charged in the Portland Metropolitan Area; and*
- c. Subject to approval by the City of Troutdale*

8. OTHER FEES

- a. Reinstatement Fee:* \$5.00 to restart service if a customer has had service suspended but has not yet been sent to a collection service
- b. Residential Collection Fee:* \$15.00 to pay collection costs of a customer that has been submitted to a collection service. This charge applies even if a customer does not reinstate service.
- c. NSF Check Fee:* \$20.00 to compensate for bank charges and the processing time to handle stopped or insufficient fund checks.
