

RESOLUTION NO. 1823

A RESOLUTION CONSENTING TO THE TRANSFER OF A LEASE AT WATER RESERVOIR #2 FROM VOICE STREAM PCS LLC TO T-MOBILE WEST CORPORATION

THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:


1. In August, 1996, the City Council approved Resolution No. 1276 entering into a lease agreement with Western PCS (now Voice Stream) for rental of space at water reservoir #2, 24451 Stark Street.
2. T-Mobile desires to simplify its corporate structure by combining its subsidiaries and has requested the City's consent to transfer the lease to another T-Mobile subsidiary, T-Mobile West Corporation.
3. Section 13 of the lease states that "Tenant will not assign or transfer this Lease or sublet all or any portion of the Site without the prior written consent of Landlord, which consent will not be unreasonably withheld, delayed, or conditioned."

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROUTDALE

Section 1. The City Council approves and the Mayor is authorized to sign the consent form, attached hereto and made a part hereof, consenting to the transfer of a lease agreement for water reservoir #2 at 24451 Stark Street from Voice Stream (formerly Western PCS) to T-Mobile West Corporation.


Section 2. This resolution is effective immediately upon adoption.


