A RESOLUTION AUTHORIZING THE MAYOR TO REQUEST THE CONSOLIDATION OF TAX LOTS ASSOCIATED WITH THE WELL HOUSE NO. 5 AND SITE IMPROVEMENTS PROJECT

THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:

1. The City of Troutdale owns two adjacent tax lots (State ID #'s 1N3E35-00100 & 1N3E35BA-13000) that are the site of the Well House No. 5 and Site Improvements project.
