

## RESOLUTION NO. 1973

### A RESOLUTION AMENDING THE FEES AND CHARGES SCHEDULE TO INCLUDE ATTACHMENTS F-1 AND F-2 RELATING TO BUILDING RENTAL FEES.

#### THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:

1. The Troutdale City Council approved the City of Troutdale Fees and Charges Schedule on June 24, 2008.
2. Section 7a of the Fees and Charges Schedule pertains to fees and charges for rental and use of city buildings. The language adopted by Council in this section references Attachments F-1 and F-2, which outline the rental and use fees for city buildings. However, Attachments F-1 and F-2 were inadvertently omitted from the Fees and Charges Schedule presented to Council on June 24, 2008.
3. There were no proposed changes to the fees for rental and use of city buildings in the Fees and Charges Schedule adopted by Council on June 24, 2008.

#### NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROUTDALE

**Section 1.** Attachments F-1 and F-2 (attached) of the Fees and Charges Schedule are hereby adopted and shall be made part of the Fees and Charges Schedule adopted by the Council on June 24, 2008 by Resolution No. 1954.

**Section 2.** The Resolution shall take effect immediately.


