

RESOLUTION NO. 2020

A RESOLUTION APPROVING AMENDMENT #1 TO AN INTERGOVERNMENTAL AGREEMENT AMONG THE TRI-COUNTY METROPOLITAN TRANSPORTATION DISTRICT OF OREGON, THE CITY OF TROUTDALE, AND THE CITY OF PORTLAND FOR TRANSIT POLICE SERVICES.

THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:

1. It is necessary and desirable to endorse and adopt Amendment No. 1 to the Intergovernmental Agreement between the Tri-County Metropolitan Transportation District of Oregon (Tri-Met), the City of Troutdale and the City of Portland Transit Police Services.
2. It is important to partner with Tri-Met to provide law enforcement services on Max, the bus line and property belonging to Tri-Met.
3. The City of Troutdale will receive reimbursement from the City of Portland for salary and benefits, plus 10%. Tri-Met will reimburse the City of Portland for services provided by the Troutdale Police Department.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROUTDALE






