

RESOLUTION NO. 2097

A RESOLUTION AMENDING SECTION 2, PUBLIC SAFETY, OF THE CITY'S FEE SCHEDULE TO PROVIDE FOR ALARM PERMIT AND FALSE ALARM FEES IN CONJUNCTION WITH TROUTDALE MUNICIPAL CODE CHAPTER 8.12 AND RESCINDING RESOLUTION NO. 2091.

THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:

1. Alarm Permit and False Alarm fees were incorporated into the City's Fees and Charges Schedule by Resolution No. 2091 adopted by the Council on February 8, 2011.
2. Multnomah County requested a minor change in our language for Commercial False Alarm Late Fees to mirror the language of the other partner agencies' agreements.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROUTDALE

Section 1. Section 2, Public Safety, of the Fees and Charges schedule is hereby amended to include the Alarm Permit and False Alarm Fees as shown in Attachment A.

Section 2. Resolution No. 2091 adopted on February 8, 2011 is rescinded.

Section 3. This Resolution shall take effect immediately upon adoption.
