

RESOLUTION NO. 2193

A RESOLUTION ACCEPTING THE REPORT OF INDEPENDENT CERTIFIED PUBLIC ACCOUNTANTS ON THE AUDITED FINANCIAL STATEMENTS OF THE CITY FOR THE FISCAL YEAR ENDED JUNE 30, 2012, AND THE MANAGEMENT LETTERS (SAS 115 & SAS 114), AND THE OAR 162-10-000 REQUIRED COMMUNICATION.
