

## **RESOLUTION NO. 2413**

### **A RESOLUTION OF INTENT TO REQUEST OF THE OREGON BUSINESS DEVELOPMENT DEPARTMENT A RE-DESIGNATION OF THE THREE CITIES CO-SPONSORED COLUMBIA CASCADE ENTERPRISE ZONE AND APPROVING THE TIMELINE AND NECESSARY ACTIONS.**

#### **THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:**

1. That the Cities of Fairview, Troutdale and Wood Village, the "Three Cities", currently co-sponsor the Columbia Cascade Enterprise Zone (CCEZ) to encourage new business investment in new industrial facilities, job creation, higher incomes for local residents, and greater diversity of economic activity is in the best interest of the Cities.
2. That after following all applicable State requirements the CCEZ was adopted by the City Council on September 11, 2007 by Resolution No. 1901.
3. That the CCEZ was designated an urban enterprise zone by the Oregon Economic and Community Development Department September 28, 2007.
4. That the CCEZ per ORS 285C.245 (2) will automatically terminate effective June 30, 2018.
5. That after consultation between and among the Three Cities elected officials and staff, the Three Cities desire to co-sponsor an application to re-designate the CCEZ under ORS 285C.250 and 285C.074 for an additional 7 years until the state program sunsets on June 30, 2025.
6. That the CCEZ designated Zone Managers have formally advised, and received consultation, from the Oregon Business Development Department (OBDD) according to ORS 285C.078, and may now proceed with the additional statutory requirements.
7. That continuing the Three Cities co-sponsored CCEZ supports the successful and productive pooling of resources with neighboring jurisdictions, and will continue to promote efficiency and effectiveness in local government administration and service delivery.
8. That the time available is short for the preparation of the required application documentation, a properly noticed public hearing for all affected taxing districts, and obtaining consent from The Port of Portland Commission for re-designation, all of which must be and completed prior to June 30, 2018.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROUTDALE:**

Section 1. That the Troutdale City Council fully approves of and supports applying for re-designation of the Three Cities co-sponsored Columbia Cascade Enterprise Zone.

Section 2. That the Troutdale Enterprise Zone Manager, Erich Mueller, is authorized and directed to act jointly and cooperatively with the Three Cities staff to coordinate actions, public meetings and schedules, and to assist in the preparations of the necessary re-designation application materials.

Section 3. That the staff is authorized and directed to take all necessary actions to schedule, provide public notice, and submit for consideration, and subsequent approval by each City's Council as appropriate, the necessary resolutions and materials required by the Oregon Business Development Department, in the time and manner necessary to obtain prior to June 30, 2018, re-designation of the Three Cities co-sponsored Columbia Cascade Enterprise Zone.


Section 4. That this Resolution shall take effect immediately upon adoption.
