

RESOLUTION NO. 2182

A RESOLUTION AUTHORIZING THE CITY MANAGER TO SIGN AN AMENDMENT TO AN INTERGOVERNMENTAL AGREEMENT (IGA) WITH THE MULTNOMAH COUNTY SHERIFF'S OFFICE FOR THE REIMBURSEMENT OF WORK ZONE TRAFFIC SAFETY ENFORCEMENT FUNDS.

THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:

1. The Sandy River Bridge Project is a four year Oregon Department of Transportation (ODOT) project to replace the I-84 bridges over the Sandy River.
2. ODOT contracts with the Multnomah County Sheriff's Office (MCSO) to provide work zone traffic safety enforcement for road projects within Multnomah County.
3. MCSO partners with local jurisdictions to provide traffic safety enforcement.
4. This collaboration provides for the police department to have an active role in traffic safety in and around the Sandy River Bridge Project directly affecting our citizens and community.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROUTDALE:

Section 1. The City Manager is authorized to execute the Intergovernmental Agreement Amendment substantially in accordance with Agreement attached as an Exhibit to the staff report and to sign any addendums to this agreement that may arise during the course of the project or any other documents that are necessary to implement the agreement.

Section 2. This Resolution shall take effect upon adoption.

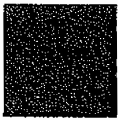
