Staff Reports

911 Equipment Needs

Police Lieutenant Dotson presented the staff report.

Councilor Triglia moved, Councilor Hodges seconded and Council voted unanimously to authorize the City Manager to execute agreement with Motorola Solutions in the amount of \$228,781 for updated computer hardware/software and paging system equipment (consoles).

Wild Rivers Coast Foundation for Dance Support Letter

Mayor Pieper presented the staff report.

Councilor Triglia moved, Councilor Hamilton seconded and Council voted unanimously to authorize the Mayor to submit a letter of support for the Wild Rivers Coast Foundation for Dance grant application.

Salmon Run Occasion Hall

Deputy PWDS Director Trost presented the staff report.

Council discussed the merits of the facility and the appropriate funding mechanisms.

Councilor Triglia re-stated his position that the money should not come out of the Transient Occupancy Tax funds. Councilor Triglia pointed out statements in the TPAC minutes of July 12, 2018 requesting edits to the June 14, 2018 TPAC minutes stating the committee's misunderstanding of the action item before them.

Councilor Hodges moved, Mayor Pieper seconded and Council voted 3-1, with Councilor Triglia voting 'nay', to authorize the City Manager to execute a purchase agreement with Hansen Buildings in the amount of \$44,567 for the purchase of a metal framed building.

Azalea Park Ball Fields Lighting-Wiring Contract

Public Works & Development Director Baron presented the staff report.

Council discussed the specifics of the project and its funding.

Councilor Hodges moved, Councilor Hamilton seconded and Council voted unanimously to authorize the City Manager to execute a contract with Stadelman Electric for the wiring of ball field lighting at Azalea Park.

Coastal Christmas Request

City Recorder Davis presented the staff report.

Councilor Hamilton noted the requested amount is too much when the TOT funds are so limited.

Councilor Triglia noted this has been a recurring event and should come out of the regular budget not TOT funds.

Mayor Pieper asked for clarification of what the bulk of the supply charges were. City Recorder Davis advised that the costs were primarily for the live wreaths.

Councilor Triglia moved, Councilor Hamilton seconded and Council voted unanimously to allocate a \$1,000 grant to the Coastal Christmas Elves downtown decorating, parade and Santa event.

Rock the Chetco Evaluation

City Recorder Davis presented the staff report.

Councilor Triglia moved, Councilor Hodges seconded and Council voted unanimously to accept the Rock the Chetco Event Evaluation report.

Remarks from Mayor and Councilors

Councilor Hamilton remarked that the community should do its part to support and fund events such as Coastal Christmas parade and decorations.

Councilor Triglia announced the designation of Kalmiopsis Elementary as a Monarch School. He thanked all those who worked to achieve the designation.

Councilor Triglia recognized the passing of Senator John McCain.

Mayor Pieper requested a recognition be done at the next Council meeting in honor of Claire Pieper who won the performing arts award at the State Fair.

Authorize the City Manager to execute and agreement with Cal-OR Life Flight for the purpose of using Salmon Run Golf Course as an alternative landing location on an emergency basis.

Financial Impact: The cost of duplicating gate keys at approximately \$10.00 each

Background/Discussion:

Salmon Run has been used in the past for emergencies landing by Cal-Or life. The City proposes to enter into an official agreement with Cal-OR Life Flight that designates specific location for medical service aircraft (helicopter) to land at Salmon Run when the Brookings Airport is unsafe to land due to weather.

Attachment(s): A. License and Use Agreement

LICENSE & USE AGREEMENT CAL-ORE LIFE FLIGHT

This License and Use Agreement ("License" or "Agreement"), dated as of _______, 2018 (the "Effective Date"), is made by and between the City of Brookings, an Oregon municipal corporation ("City") and Cal-Ore Life Flight, LLC, an Oregon limited liability company ("Cal-Ore") for the purpose of setting forth the terms and conditions upon which the City will allow Cal-Ore to use the Salmon Run municipal golf course as an alternative landing site for medical service aircraft.

RECITALS

Whereas, the City of Brookings is the owner of Salmon Run, a municipal golf course, located at 99040 South Bank Chetco Rd, Brookings, Oregon; and

Whereas, Cal-Ore Life Flight provides air ambulance service to the residents of Brookings and surrounding areas; and

Whereas, the parking lot adjacent to the clubhouse and the #1 Fairway near the parking area at Salmon Run ("Premises") are considered viable alternative landing sites to the Brookings Airport, which can become unsafe for landing due to weather conditions Brookings Airport, e.g. fog; and

Whereas, the parties desire to enter into an agreement to allow Cal-Ore to utilize the City's property for the purpose herein stated.

AGREEMENT

- 1.0 LICENSE. City hereby grants to Cal-Ore a license to use the Premises for the express purpose of landing medical service aircraft and for no other purpose. No legal title or leasehold interest in the Premises is created or vested in Cal-Ore by the grant of this license. The City may revoke this license at any time by providing written notice to Cal-Ore specifying the effective date of revocation.
- 2.0 LIMITATIONS. Cal-Ore is only permitted to land medical service aircraft on the Premises when the golf course is closed to the public (non-business hours) and Cal-Ore has confirmed with golf course management (currently the Early Management Team) that the Premises are clear for landing.
- 3.0 LICENSE FEE. The annual fee for this license is \$1.00 per year, payable upon the execution of this Agreement and on the same date each year thereafter.
- 4.0 ACCIDENT / INJURY. In the event of an accident, or injury to any person or property, arising from Cal-Ore's use of the Premises, Cal-Ore shall IMMEDIATELY notify both golf course management and the city manager. Such immediate notification shall be followed up with written notification pursuant to Section 5.0 below.

5.0 NOTICES. Any notices given pursuant to this agreement must be addressed to the party at the address listed below and sent first class, postage prepaid:

Notice will be deemed effective on the third day after the date of mailing. Either party may change its address for receiving notice by advising the other party in writing pursuant to this section.

- 6.0 COMPLIANCE WITH LAWS. Cal-Ore must comply with all local, state and federal laws, rules, and regulations pertaining to the activities contemplated herein.
- 7.0 INDEMNIFICATION. As a material part of the consideration to be rendered to the City under this Agreement, Cal-Ore waives any and all claims for damages to personal property in, on, or about the Premises and for injuries to persons in, on or about the Premises, from any cause arising at any time related to Cal-Ore's use of the Premises. Further, Cal-Ore agrees to hold the City harmless for and on account of any damage or injury to any person or personal property of any person, arising from Cal-Ore's use of the Premises. Cal-Ore agrees to pay for all damages to the Premises, and personal property located on the Premises, caused by Cal-Ore's use of the Premises.
- 8.0 INSURANCE. During the term of this Agreement, Cal-Ore is required to maintain the following types of insurance with the following minimum limits:
 - (a) General Liability. Cal-Ore must maintain a policy(s) of comprehensive liability insurance covering bodily injury, personal injury, and property damage in amount not less than \$1,000,000 per person / \$3,000,000 per occurrence. The City, its public officials, employees, and agents shall be named as additional insureds on the policy.
 - (b) Worker's Compensation. Cal-Ore must maintain workers' compensation insurance in compliance with Oregon State law.

9.0 GENERAL PROVISIONS.

- 9.01 NO THIRD-PARTY BENEFICIARIES. There are no third-party beneficiaries to this Agreement. This Agreement may only be enforced by the parties.
- 9.02 ASSIGNMENT. This License is personal to Cal-Ore and may not be assigned to any other party. Any attempt to assign the License will automatically terminate it.
- 9.03 ATTORNEYS' FEES. If any legal action or proceeding arising out of or relating to this Agreement is brought by either party to this Agreement, the prevailing party shall be entitled to receive from the other party, in addition to any other relief that may be granted, the reasonable attorneys' fees, costs, and expenses incurred in the action or proceeding by the prevailing party.

- 9.04 INTEGRATION. This Agreement constitutes the entire agreement between the City and Cal-Ore relating to the license. Any prior agreements, promises, negotiations, or representations not expressly set forth in this Agreement are of no force and effect. Any amendment to this Agreement shall be of no force and effect unless it is in writing and signed by both parties.
- 9.05 GOVERNING LAW / VENUE. This Agreement will be governed and interpreted in accordance with the laws of the State of Oregon. Any litigation between the parties under this Agreement or arising out of activities performed under this Agreement must be filed in Curry County Circuit Court or the U.S. District Court for the State of Oregon, as appropriate.
- 9.06 AUTHORITY. Each signatory hereto represents and warrants that he or she has been duly authorized to sign this agreement on behalf of his or her respective party.

Pro-tem Judge Gary Milliman, Public Safety Director Kelby McCrae, and I have been in meetings with the Brookings-Harbor School District, and the Curry County Juvenile Department about the possibility of having a "truancy court" in Brookings, through municipal court.
