1. PLEDGE OF ALLEGIANCE, ROLL CALL, AGENDA UPDATE.

Mayor Ryan called the meeting to order at 7:02pm.

2. PUBLIC COMMENT: Public comment is limited to comments on non-agenda items.

3. MOTION: A motion to approve the winners of the Mayor's Coloring Contest.

These keep us in compliance with the local budget laws. There is no increase in appropriations, only transfers and reallocations. This is a customary resolution that I bring to the Council each year. This year it was a \$203,000.00 transfer of contingency in the General Fund whereas last year it was \$480,000.00.

Motion passes 7-0.

5. STAFF COMMUNICATIONS
