Public Arts Committee - March 17, 2014

Baron reported they are awaiting a Flora Pacific bid for landscaping the property at the southern edge of town

Brookings WELCOME sign: Discussion-Baron reported on the sign challenges (vandalism, etc.) and that they are looking at draught resistant plants; he authorized weed pulling at the site. Clapson will get a work party together to beautify the sign. All committee members will work on beautifying the sign.

- Farr will report on the other 'welcome' sign north of town.
- > Baron noted there is a welcome sign at the south end of town.

Baron reported the number of PAC board members was set at five by the city council. More research would be needed to possibly increase this number.
