

CITY OF BROOKINGS
Public Arts Committee – April 7, 2014

Members present: Committee Chair Lea Ray, Scott Clapson, Jackie Farr, Judy May-Lopez, Destiny Schwartz

Also present: PW/DS Director Loree Pryce; Parks/Tech Services Supervisor Tony Baron; Michelle ___ and Jane Stebbins

Meeting called to order at 11:04 by May-Lopez. Motion made by Clapson and seconded by Schwartz to approve the minutes of the March 17 meeting. Motion carried.

Old Business

Murals:

- Salon Dolce: Baron reported the sign structure bracing is broken and needs to be replaced and re-screwed. Needed are a 4x4 or 6 post, hold and two bags of cement (about \$30-plus labor). He further reported this is not city property so would not fall under the "bid guidelines." Clapson will follow-up on possibilities to get this ready for the mural installation by June 1st. Stebbins reported she had a bag of cement that can be used.
- Pool: Farr presented information possibilities and will work on final plans that need to be presented to Parks and Recreation and the City Council. She is also working on a marketing plan (starfish would be painted different sizes at different prices; monies realized would possibly go towards swimming scholarships). The finished package will need to go to Parks & Recreation committee and then to the city council in late May.
- Kid Zone: Ray and May-Lopez met with property lessee, she is agreeable to mural possibilities. A mural application will be completed.
- Food Bank and Fleet Street – discussion followed, with possible PAC press release and teaming up with Art Walk. May-Lopez will send copy of the March social comments to Michele Hanna and Pryce will forward to her a mural application.
- Southern entrance to city: Baron reported they are awaiting bid information (Flora Pacific) for landscaping this property. Clapson will investigate including this as a monthly service project.
- Brookings WELCOME sign: Representatives from Pelican Bay Arts are working to finish this sign so the PAC will not be involved.
- NEA Grant: May-Lopez reported she is reviewing info and expects to forward to committee members within a week.
- Food is Free – will discuss at upcoming meeting

New Business –

- Pryce reported a new business is relocating (lot off Easy) and this would be a possibility for PAC mural.
- Discussion on a community bulletin board (interactive, collaborative space)
- Discussion on permanent squares marking art walk alley.
- Possibility of planning a PAC social every six months (September?).

Meeting adjourned at 12:15 p.m.


PAC Meeting Date: Next meeting April 21st, 11am.
