### ITEM 1. PLEDGE OF ALLEGIANCE, ROLL CALL, AGENDA UPDATE

Mayor Cox called the May 23, 1989 Regular City Council meeting to order. Mayor Cox called on Councilor Fowler to lead the pledge of allegiance.

City Recorder, Valerie Raglione, called the roll.

#### ITEM 2. CONSENT AGENDA:

MOTION: Councilor Bui moved to approve the consent agenda as written (2.1 Accept: Minutes of 5/9/89 - Regular Mtg.) Councilor Jacobs seconded the motion. YEAS: 3

#### ITEM 3. PUBLIC COMMENT:

Mayor Cox called for any comments from the audience not listed on the agenda. There were none.

### ITEM 4. PUBLIC HEARING: Marine Drive/Sundial Road Water & Sewer Extension LID 89-002 Project

Public Hearing Opened - Mayor Cox opened the public hearing.

Declarations or Challenges - There were none.

Summation by Staff - Wilder stated that the Community Services

Department report was provided to Council for their review at

the previous meeting. Council accepted the preliminary report. The estimated cost of the total project is \$750,000 which includes the construction of water line and sewer facilities, sewer pumping facilities to service recently annexed area along Marine Drive and Sundial Road.

Exhibit B reduced the scope to \$487,787 as opposed to the original \$750,000 proposed. Staff requests that the gravity sewer line portion be tabled for thirty (30) days for consideration.

### Public Testimony:

Proponents - The consulting engineer was in the audience for questions. The Railroad had called and stated that they did not intend to remonstrate against the project.

PGE wants to share the water trench with the City. A negotiated sharing cost will need to be worked up for that cost.

John Spencer, 12245 NE Whitaker, Portland, OR 97230. Landowner of 25 acres and closing on an additional 25 acres across the street later in the week. He has 22-23% of the cost of the facility + the costs of his own pump station (\$200,000 + or - for him). He is a proponent of the project. In constructing a facility on the northern portion of the property the utilities are a necessary for his operation. They had originally asked the City, when purchasing the property, if they could be involved in an L.I.D. It is mandatory for development of his property. \$2.5 million is what he has invested on one portion of the property. He stated that it was anticipated that another \$4-\$5 million would be spent.

A sub-station would need to be put in by PGE and negotiations with staff on the trench would reduce his costs — there is a benefit with the amount of electricity that will be used.

Sebastian Degans, 700 NE Multnomah, Portland 97208. He stated that the Port of Portland was a proponent of the project and a tentative planned approval had been received for a subdivision of the property (24 acre parcel). The pump station and water service would provide some of the services to the site allowing marketing of the properties for industrial development. The Port has reviewed preliminary information and is satisfied with the L.I.D.

Randy Reese, 1005 SE 23rd, Troutdale. He is a citizen and professionally affiliated with the facility to be built on John Spencer's property. He was speaking as a citizen and wanted to encourage the approval of the L.I.D. At a recent Kiwanis meeting he had heard that Troutdale was really expanding and growing rather than hearing 'why do you want to live out there where the wind is?' He felt it was essential to develop and grow. He didn't want a message sent that Troutdale wasn't interested in

development. He wanted to stay in Troutdale and see it prosper.

Opponents - Dan TenEyke, 49495 SE Marmot Rd., Sandy 97055 -Engineering Manager Troutdale Reynolds Plant read from a written statement (on file with 5/23/89 packet/City Recorder). Mr. TenEyke read the letter from the Plant Manager. Reynolds wished to have any decisions on the project postponed; May 4th notice Reynolds; felt that \$423,165 cost to the notice applicable to the proposed project; weren't in a position to assess the project with the inadequate and incomplete notice; take a position at this time or loose the right to voice any reservations; must remonstrate against the approval of L.I.D. Strongly objected to the inadequacy of the procedures taken by the City to inform affected property owners about the nature and extent of the improvements; the rapid pace that the City has moved to institute L.I.D.'s.

Recommendation by Staff - Wilder stated that staff was asking that the project be separated into two schedules. Water together with sewer pump stations on one schedule. 1) items can be constructed regardless of the groundwater conditions; 2) necessity for the water system to be completed before sanitary sewer to allow dry wells points to de-water the trenches to build the sanitary sewer; 3) the engineering efforts are finding that not all property owners will be equally benefited by the sewer, however, would be by the water and pump stations. For gravity sewer line itself, there is a decreasing benefit as you get away from the line, calculations need to be done to determine the benefit in a decreasing value to put together a preliminary assessment role for that.

Council Questions or Comments - Councilor Fowler asked if the property affected on Reynolds is the area from Airport Road to the end of the line? Was there was a portion that would not be built? The northern portion across the railroad tracks?

Wilder stated that it was 58% and the ordinance requires 67% of remonstrations to stop the project. Wilder stated that it would all be built if the tabled public hearing created a successful second schedule to the L.I.D.

Councilor Fowler asked about the pumping station? Wilder responded and indicated the locations on the map.

Councilor Bui asked what TenEyke felt Reynolds had not been involved in? He stated that Reynolds didn't know what the assessment was. They didn't know what the total impact of the project would be.

Wilder stated that Reynolds knew what the total impact was of the \$750,000 project. The ordinance allows Council to review public testimony and make changes in the Report at Council discretion. Wilder stated that had been done for the water and wastewater pumps. Reynolds would be \$283,697 if elected to table the sewer portion to further discuss with Reynolds and other affected property owners.

Councilor Fowler asked if there would be anything done different in the sewer line by eliminating Reynolds or would the same sewer line be built? Wilder stated no, in fact it would still be built in the same timeframe. The waterline has to be built first in order to de-water the sewer line trenches. It gives Reynolds (and anyone else wanting to do so) an additional month to do so.

Councilor Fowler asked if the sewer would be built this year? Wilder stated yes, as late in the construction season as possible to get the costs as low as possible based on the groundwater conditions.

Councilor Fowler didn't feel there was a choice. If it wasn't done, everything else in the area can't move.

Mayor Cox stated that the sewer issue could wait another month. Wilder stated that there would be a second public hearing which would be in a month. That allows ample time to do construction advertising, contractor selection. It wouldn't create any problems and doesn't add anything to the cost and it fits the schedule.

Christian stated it was recommended that the LID be formed for the water lines pursuant to the resolution in the packet; an additional six weeks (July 11, 1989) to hold a hearing on the sewer portion of the LID. Christian commented on the notice for the LID. Approximately 18 months ago when the City annexed the portion, the first request was turned down due to comment made by Reynolds Metals. At that time, a compromise was reached on this new property -- it was made very clear how the City felt about the property, the entire system (both water and sewer) have been designed to serve the property at a future date. The property is in our urban growth boundary. There has certainly been notice that the property was due to be served upon request...as long ago as 18 months. There was ample opportunity for comment from Reynolds. The City has prided themselves in the past three years to be ready, willing and able to deal with any development that came in. Get it to Council quickly, address it from a technical standpoint for services that are needed to serve the property. Mr. Spencer was in late March/April. The quickest way to respond to his request for service was a Council initiated LID. It is a much more rapid process and petitions from all the affected property owners aren't required. Mr. Spencer's property is closed and it is a done deal. Council started the process in a timely fashion to respond to his needs. It is fast, however, Reynolds has had as much notice as the City had.

Councilor Bui asked if any of the executives from Reynolds met with staff? Christian stated that the Mayor, Greg Wilder, Christian had met with the Plant Manager and Mr. TenEyke on

Friday morning past. Councilor Bui asked what the outcome of the meeting was? Christian stated that it was about what had been heard at the present meeting.

Wilder stated that he had met with Mac MacElroy and then with MacElroy and Mr. Jones prior to that meeting. The public notice was greater than that required by State Statute and by City Ordinance both the Virginia facility and the local facility had been notified, as well as posting the required notices. Christian stated that notifying the registered property owners is the requirement and that would be in Virginia.

### ITEM 6. ORDINANCE: West Columbia Sewer Extension 79-1 Assessment Adjustment (524-0)

Christian stated that this item was carried forward at the request of the Council regarding an appeal heard at the May 9 meeting. This ordinance was in response to direction from Council and re-spreads the assessments in that particular 1979 LID.

Christian stated that the non-remonstration agreement was only for Council review and not for action. If the ordinance is passed, the affected individual would be requested to sign the agreement as well as a representative from the City.

Mayor Cox read the Ordinance by title. He called for questions or comments from Council. There were none.

The City's contribution to the project will be \$44,776.00; Reynolds School District will contribute \$86,324.00; CDBG's contribution will be \$131,100.00.

Public Testimony (Proponents, Opponents): Mayor Cox called for public testimony, proponents or opponents. There were none.

Christian stated that since the City received two requests from property owners outside both the City limits and the urban growth boundary, City staff has reviewed existing resolutions and ordinances regarding this matter and found conflicts in them with current State statute. This ordinance will set forth the process and procedure for extra-territorial service and will either amend or delete those ordinances in conflict with State statute, and will also take into consideration pending legislation dealing with allowing the extension of services to "non-contiguous" annexations.

Mayor Cox called for comment or questions from Council.

Councilor Fowler moved to pass the ordinance as written. MOTION:

The last response received from the Highway Division states that they will be reviewing the situation and that the City would be notified of the results when the review is completed.

Wilder gave background information on this item. He stated that the pump station is complete and operating and pumping at a greater capacity than originally estimated. The project was completed under budget by \$5,534.00. He stated that it is staff's recommendation to Council that the release of the final payment and retainage to the contractor.

#### ITEM 14. SURPLUS PROPERTY SALE: TAX LOT 42, SECTION 25

Christian read a letter from Jim Jennings regarding Mr. Bennett's request for a 60-day extension of time to complete financing. Jennings stated in the letter that since Mr. Bennett is in breach of the terms and conditions of the sale originally imposed by Council, and that the City has several alternatives available: 1) to void sale to Bennett and find a new buyer through the bid process; 2) re-affirm the contract with Bennett with whatever changes might be appropriate including, but not limited to, interest accruing on the balance due (\$154,000.00) for 60 days; or 3) grant an extension of time to Bennett without any changes in the contract.

Mayor Cox called for questions or comments from Council.

Councilor Bui stated that he would like to re-affirm the contract with Bennett adding a 10% penalty fee on the balance of the contract for 60 days.

Councilor Thalhofer asked if the 10% fee is appropriate.

Gazewood stated that the current interest rate is 9.35% so the suggested 10% rate would be appropriate.

MOTION: Councilor Bui moved to grant the extension contingent upon a 10 % interest rate fee for the sixty days and that nothing further be done on the property until the sale is consummated. Councilor Thalhofer seconded the motion.

### ITEM 16. REQUEST FROM TAD'S -- L.I.D.

Wilder stated that a request from Tad's restaurant has been received asking the City to investigate the possibility of forming a local improvement district to address DEQ's concern regarding the waste water disposal problem at the restaurant. If an L.I.D. is formed, it could provide pressure main service only for a few other property owners on the east side of the river and could also serve the City's Community Park needs. The majority of costs for such a project would be the restaurant's responsibility. The other two homes possibly contributing to the system would probably proportionately assessed based on a comparison of their discharge to that of Tad's. The City's involvement would be close to the end of the project, and would be in line to those amounts currently budgeted to provide waste water disposal at the City Park. Staff recommends that Council authorize, by motion, the Department of Community Services to prepare the necessary report. The report could not be completed until some time in July due to the analysis and research needed.
