## THE PLANNING COMMISSION TOOK THE FOLLOWING ACTION

By a unanimous vote (motion: Commissioner Breuer, second: Commissioner Holmes) the Planning Commission recommended for approval a County referral of a request for a County Comprehensive Plan Change and Zone Change from R-2 to C-1 to expand the Portside R.V. Park; a 1 acre parcel located at 16219 Lower Harbor Road submitted by Kenneth L. Byrtus.
