MINUTES

By a unanimous vote, (motion: Commissioner Herzog, second: Commissioner Freeman), the Planning Commission approved the minutes of the April 7, 1992 Planning Commission regular meeting with the following additions on page 4, paragraph 2: "..if he has been getting notice of Minor partition within the UGB; she said that the County Planning Director grants Minor Partitions and Variances administratively while the city holds a public hearing on these matters.", also on page 4, paragraph 4:"...she felt it was necessary for the Commission to review such items so that the neighboring property owners would be aware of what conditions were being place on the project.

THE PLANNING COMMISSION TOOK THE FOLLOWING ACTION IN THE PUBLIC HEARINGS

1. By a unanimous vote, (motion: Commissioner Herzog, second: Commissioner Freeman) the Planning Commission approved a request for a minor change to the approved conditional use permit (CUP-2-90) to allow the parking lot to be redesigned and to place a smaller church building on the 3.5 acre site, located on the east side of Highway 101 south of Parkview Dr. in and R-1-6 zone, submitted by the Church of the Nazarene.

By a unanimous vote, (motion: Commissioner Breuer, second: Commissioner Branscomb) the Planning Commission approved a request for a minor partition on a .39± acre parcel to create 2 lots of 8,498 and 8,631 sq. ft., located on the west side of Tanbark Rd. extending to Cove Rd. approximately 300 feet south of the intersection of Memory Ln. (207 Tanbark Rd.) in an R-2 zone, submitted by Jay and Michele Breuner.

Mahar.

REPORT OF PLANNING DIRECTOR

The Planning Director asked how the Commission liked the double sided formate for the agenda packet. The Commission indicated that they liked it.

Commissioner Krebs asked if there was anything new on the Urban Reserve Area issue? The Planning Director related to the Commission what had occurred at the April 17, 1992 LCDC hearing on the Urban Reserve Rule and that the Rule was passed and that Brookings was still one of the seven cities mandated to create a Urban Reserve Area. He went on to say that the City Attorney has been asked to look into the possibility of appealing the ruling. He went on to explain the options the city had in response to the ruling. Josephine County had contacted the County (Curry) asking if they were interested in joining them in an appeal of the Rule and he, the Planning Director, would call Josephine County the next day to discuss their action. Discussion of the issue followed. Commissioner Krebs read the concerns that the City and County Planning Directors took to the LCDC meeting.

Commissioner Krebs reported that Commissioner Branscomb and she had attended the Town Hall meeting on sewers and the City Council workshop with Harbor Sanitary District and she was encouraged with the work accomplished.

There being no further business before the Planning Commission, the meeting was adjourned at 9:50 p.m.
