By a 5-0 vote, [Commissioner Freeman abstaining due to his absence at the November 2, 1993 meeting] (motion: Commissioner Breuer, second: Commissioner Lindsey) the Planning Commission approved the minutes of the November 2, 1993 Planning Commission regular meeting, following some minor corrections.

#### PROPOSITIONS AND REMARKS FROM COMMISSION MEMBERS

Commissioner Breuer stated that the earlier case pointed out the necessity of the city establishing some hillside development standards.

Chairman Freeman asked how the Commissioner Training Session was. The general consensus was that it was very worthwhile.

Chairman Freeman stated that the four new members did very well at tonight's meeting.

The Commission discussed the issue of potential conflict of interest. It was determined that more information was needed.

Chairman Freeman introduced the issue of the Annual Planning Commission Report to the City Council and that they had received a summary of last years joint meeting with the Council. The Chairman asked each Commissioner to submit their concerns or items they felt should be discussed. Commissioner Krebs explained how the joint work-study session with the City Council worked. Discussion followed regarding the items to be covered.

Commissioner Lindsey asked about the new state law requiring cities to allow manufactured homes in all residential zones that allow single family homes. The Planning Director explained that the law required the city to submit proposed ordinance changes to them for comment by January 1, 1994 and to enact the law by May of 1994. Discussion followed.

Chairman Freeman asked about the issue of driveways for three car garages. The Planning Director said that he did not have time to look into the issue and said that his concern was where to draw the line.

There being no further business before the Planning Commission, the meeting was adjourned at 12:15 a.m.
