PROPOSITIONS AND REMARKS FROM COMMISSION MEMBERS

Commissioner Ambrose announced that due to the number of meetings that he had missed, Chair Freeman had asked that he resign from the Commission. He stated that the meetings he had missed were due to business conflicts and since the situation was not likely to change, he had agreed to resign.

Commissioner O'Holleran asked if the Hillside Development Standards have been adopted. The Planning Director explained that the standards had been adopted but the Council was investigating the possibility of amending the standards to require a bond.

Commissioner O'Holleran asked about the status of the Urban Growth Boundary expansion. The Planning Director explained that the city had interviewed candidates for the consultant to finish the findings and justification process. The interview committee Councilor Curry, Commissioner Breuer, Acting City consisted of Manager Lightle, County Planning Director Chuck Nordstrom and himself. The committee has made a selection that would be taken to City Council the next Monday (August 22, 1994) confirmation. Some discussion followed.

Commissioner Krebs stated that the County Commissioners have asked for volunteers to reactivate the Committee For Citizens Involvement and that it would be a fifteen member committee appointed geographically with five members from the Brookings Harbor area. This is a result of the county just entering periodic review. She went on to say that the deadline to apply was August 31, 1994.

Commissioner Krebs called attention to the new front cover of the agenda packet which spells out the hearing procedure and states that the applicant or representative must present the case and not just stand up and agree with the staff report. She went on to say that the bottom half of the sheet [where it talks about testimony must relate to the criteria and that failure to raise an issue prevents appeal on that issue] is state law and not just something that they had thought up and she wanted everyone to understand why it is on there and that it keeps us legal.

Commissioner Krebs stated that the day that the press calls her at home to ask why she was not at a meeting is the day they should be taken to task. There was no press representation at this special meeting. She stated that she serves because she cares enough about it and is sure that everyone else does also and that it is not their (the press) place to call and ask why they were not at the

meeting. If the Mayor or the Planning Chairperson wants to call that's fine but it is not the presses place to do so. Commissioner Breuer said that the next time the press calls him at 10:00 at night because they must meet a deadline [because they did not attend a meeting] he would tell them goodnight.

The Planning Director pointed out that since the city's appeal process was a de novo hearing, the clause in the procedure that relates to failure to raise an issue prevents appeal based on that issue is moot, because de novo means a brand new hearing as if no other hearing had been held. The clause would apply to an appeal to LUBA but not an appeal of a Commission action to the City Council. Some discussion followed.

There being no further business before the Planning Commission, the meeting was adjourned at 10:01 p.m.
