REPORT OF THE PLANNING DIRECTOR

The Planning Director gave his quarterly report which included the following items:

- 12. Chairperson Freeman asked about the sludge situation. The Planning Director explained that the city has explored a couple of possibilities but he did not know many details. Chair Freeman said he heard of a system where sewage from individual homes was first sent into a septic tank and then to the treatment plant.

Discussion followed some of these items.

The Planning Director asked the commission to give him what they wanted to see on for the amendments on the cover sheet of the agenda packet and does the Commission want to place a time limit of the length of testimony. Some discussion followed. The Chair Freeman said that they would get something to the director.

The Planning Director also pointed out the monthly EDU count report. Discussion followed on how many more hookups were left.

PROPOSITIONS AND REMARKS FROM COMMISSION MEMBERS

Commissioner Krebs asked about the LUBA remand. The Planning Director explained that the LUBA appeal of the ordinance allowing rehabilitation facilities with a retail store, was remanded back to the city. LUBA did not challenge the city's authority to allow the use but since the city's Land Development Code required findings to enact such an ordinance, it was LUBA's opinion that the presented findings were weak and should be strengthened. The was state law requiring findings on legislative matters. At this time the applicants attorney is working on the findings. Discussion followed.

Commissioner Krebs asked about the water meeting on May 17. The Planning Director said that he was not familiar with the meeting. Nancy Brendlinger (City Council liaison) explained the intent of the meeting from the audience.

Chair Freeman asked Ms. Brendlinger why the Council had passed the ordinance requiring the 12 inch roof overhang? It was explained that the Council denied the ordinance.

Commissioner O'Holleran asked if the special meeting would be on May 24 at 7:00 P.M. The Planning Director confirmed the time and date.

Commissioner Breuer asked if the Commission had granted Mr. Chandler the right to move a house onto a property which already had a house and was zoned for only one house. The Planning Director said that if a house was moved it was before he was here. The Commission did grant a zone change on the property and both houses were on the lot at that time.

Commissioner Krebs asked if the Commission was concerned that the county was changing there ordinance to the tune of 218 pages and has not asked the city for comment? Discussion followed and resulted in a motion that the Planning Director to look into the matter. Commissioner Krebs asked that the City Council ask the County Commissioners about this at the next Council/Commissioner meeting. Commissioner Breuer asked if the Council could ask why there has never been a citizen of the City of Brookings on the County Planning Commission. Discussion followed.

Commissioner Ciapusci said that he had enjoyed the joint Planning Commission/City Council work study session and was looking forward for more.

Commissioner Lindsey said that there was a large pickup and a flat bed truck on the Hays' property on Fifth St. and one night the rear of the flat bed was protruding into the street and he had to stop to let another south bound car go by or he would have hit the truck. Discussion followed.

Chair Freeman asked about a work session on an ordinance on procedures and policies and creation of a manual. Discussion followed.

There being no further business before the Planning Commission, the meeting was adjourned at 9:43 p.m.
