By a 6-0 vote (Motion: Commissioner Dundom) the Planning Commission approved an application File No.PUD-1-04/MC-3-07, for a minor change to alter Condition #20 of Pacific Terrace PUD, PUD-1-04, removing the requirement for 4 foot shoulders along the frontage of the subject property adjacent to Old County Road.
- 2. By a 6-0 vote (Motion: Commissioner Markham) the Planning Commission approved the Final ORDER and Findings of Fact for File No. **PUD-1-04/MC-3-07.**

- 3. <u>CR-LL-0711</u>-a lot line adjustment to 16920 and 16950 Old County Road-Wong/Hedenskog, applicants.
