MINUTES OF THE REGULAR MEETING OF THE CITY PLANNING COMMISSION, June 16, 1953

MEETING called to order at 8;15 by Chairman, Chas. Young.

Members Present: O.D. Arp, Elmer Bankus, Arthur Knox and James Yelton.

MINUTES of the previous meeting read and approved.

REPORTS OF COMMITTEES:

Mr. Arp reported that the City Council and the City Budget Committee had approved an item of expense for the Planning Commission in the sum of \$450.00%

Mr. Arp also reported that Mr. McClain's petition for zoning change had been found insufficient and had been returned to him for compliance.

The secretary read letters from the Speed Control Board and the State Highway Commission in reply to ours protesting present established speed rates thru our City. Mr. Young reported that the City Council was planning an active campaign to get these speeds lowered and that the City Attorney was preparing a resolution citing speed zones in specificly named cities based on first hand knowledge and information.

The secretary reported that the City Council had approved the proposal of County Clerk, Mrs. Oleta Walker, to divide the Brookings voting precinct into a North and South precinct using U.S.Highway #101 as a dividing line. Mrs. Walker advised that Brookings had become too large to function as one precinct and that it was mandatory by law that this division be made in July of this year.

The Secretary also reported that registration of voters would be done hereafter in the City Recorder's office and that a duplicate of all registrations would be kept on file in that office at all times.

Mr. Arp reported that street sign locations were already placed.

Mr. Young reported that he and Mr. Arp had located 23 new street light placements and presented them to the Commission for study to accept or reject. After due consideration the following twenty locations were decided upon and the secretary to so advise the Mayor:
