MINUTES OF THE REGULAR MEETING OF THE CITY PLANNING COMMISSION, March 1st. 1955

Meeting called to order by Chairman, Ed Aldrich.

Members present: Messrs. Aldrich, Yelton, Tygart, & Swan, Stanhurst, Goetz, and Weideman. Ex-officio member, Mayor Brimm, also Mr. Bankus and Mr. Reed.

Minutes of the previous meeting read and approved.

New Chairman lected:

The chairmanship of the Commission being declared vacant by the departure of Mr. Osborne from the city, Nominations for that office was called for by acting chairman, Mr. Aldrich.

LeRoy Weideman was nominated by Mr. Yelton, seconded by Mr. Swan, nominations declared closed, and the secretary instructed to cast a unanimous ballot for Mr. Weideman. Unan. carried.

Whereupon the chair was relinquished to Mr. Weideman.

New Member:

New member, Mr. Gordon Goetz, was formally welcomed into the membership.

Old Business:

Secretary reported that the City Atty. Mr. Ackley had recommended that the Bldg. Inspector, Mr. Reed investigate and find out if the beer binghe Rainier Brewing Company at Norgate violated the bldg. code.

Mr. Reed presented samples of house numbers and gave his report. Action now up to the Council.

New Business:

The letter of Mr. Rice, representative of Cornell, Howland, Hayes, and Merryfield pretaining to the proposed survey, was read.

Motion was made by Mr. Yelton, seconded by Mr. Tygart that the Planning Commission advise the 'ity Council that it is entirely and whole-heartedly in accord with the proposal of the City Council to authorize a water and sewer survey and that any saving that can be derived from consolidating the two, should be considered. Carried.

Motion was made by Mr. Stanhurst seconded by Mr. Aldrich that the Planning Commission recommend to the City Council that a R.O.W. be acquired for a street to connect Ransome with U.S. Highway 101 by way of 5th st. and also acquire a R.O.W. along 7th st. to connection Fioneer Rd. with Facific Ave. Carried.

Motion was made by Mr. Tygart, seconded by Mr. Yelton that the Council's attention be called to the need for slow or stop signs at the intersection of R.R. Ave. and Center St. and also at R.R. Ave.

Wharf St. and Memory Lane to cut down speed at these danger spots.

Motion was made by Mr. Yelton, seconded by Mr. Swan that the City Council call the State Fire Marshall's attention to the accumulation of grease on the roofs of buildings that house restaurants.

Mr. Bankus was present to discuss a replat of Plat no.1. He was advised to get a petition signed by property owners in the area and present it to the Planning Commission for regular procedure. Incorderito get the full picture of the proposed change, the members of the planning commission agreed to go with Mr. Bankus and inspect the grounds before the next meeting.

Motion was made by Mr. Swan, seconded by Mr. Aldrich that meeting adjourn until April 5, 1955.
