REPORT OF COMMITTEE APPOINTED BY THE CITY COUNCIL TO INVEST

LIZZ ARPARTMENTS:

This building is in bad conndition, the foundation is bad, the plumbing is not up to standard and the electric wiring is beyond repair.

It is recommended that if the building is used for occupancy that the wiring should be replaced with wiring that will pass the code.

Some repairs should be made on the plumbing.

The Strutural condition is such that it is recommended the no rentals be allowed on the second floor and that some method of heating and cooking, other than wood should be provided.

VINCENT BUILDING:

The electric wiring in this building is in bad condition and the building should be re-wired on the second and third floors.

The plumbing on the upper floors is also in bad condition.

Due to the condition of the entrances it is recommended that no rentals should be allowed on the third floor.

BLUNT BUILDING:

The Structural condition of this building is not bad, in fact no worse than many other buildings in the City, a permit has been issued to make certain repairs on the building and this is being done. Mrs Blunt also plans to paint the building.

It is recommended that the wiring in the building be replaced in accordance to the code.

It is recommended that some approved type of Fire Alarm be installed in all of the above buildings, such Fire Alarm should be energized by battery and not by transformer.

This report is submitted to the Brookings Planning Commission for action and recommendation to the City Council.

The State Electrical Inspector was present with the undersigned when inspection was made.
