

REGULAR MEETING OF THE CITY PLANNING COMMISSION  
April 3rd. 1956

Meeting called to order by Chairman, Roy Weideman.

Members present: Messrs. Fox, Goetz, Hanks, Stanhurst & Weideman.

Others present were Mr. Bullock and Mr. Reed.

Minutes of the previous meeting were read and approved.

New Members Appointed:

Chairman Weideman advised that the Mayor and City Council had appointed Alden Loring and Merrill Bullock as planning commission members to fill the vacancies of Jim Kirby and Frank Tygart, whose respective offices expire April 21, 1956. Term of office for Messrs. Loring and Bullock to be four year terms expiring 4/21/60.

Mr Weideman also reported that the Red Comet type of fire extinguisher was finding universal favor in Brookings.

Old Business: Recommendation #17 (Fern Ave.) 2-way St.)

A discussion was held with the City Council at this time on the matter with the result that the City Council moved to approve this recommendation of the Planning Commission.

The plans of the Consolidated Freightways to build a freight terminal on the corner of R.R. Ave. and Wharf street was presented by Mr. Reed together with map showing set-backs etc. Motion was made by Mr. Fox, seconded by Mr. Goetz that the plans of Consolidated Freightways be approved as presented. Unan. carried.

Meeting of the Interim Committee at Coos Bay to discuss the subject of Fringe Areas was considered. It was decided that all members of the Commission should attend if possible. Messrs. Weideman, Fox, Stanhurst, and Goetz agreed to attend. All members to present questions pertinent to our situation, for consideration and answer. Motion was made by Mr. Fox, seconded by Mr. Goetz that expenses for this trip be paid out of Planning Commission expenses and that the secretary's bill for \$25.00 from January 1st. 1956 to and including April 3rd. be allowed. The acquisition by the City of the Wrangler's Rodeo Grounds and  $4\frac{1}{2}$  acres adjacent for a City Municipal Park was discussed with the City Council.

RECOMMENDATION# 23

(Purchase by City of Wranglers' Rodeo grounds and  $4\frac{1}{2}$  acres adjacent for City Park)

Motion was made by Mr. Fox, seconded by Mr. Hanks that the Planning Commission be advised to the City Council that it favors the acquisition by the City of the area being presented to the City by the Wranglers and that it recommends that options be obtained on the four and one-half acres more or less belonging to the Carson, Moore Lbr. Company. Unan. carried.

Motion was made by Fox seconded by Hanks that meeting adjourn.
