OF THE CITY PLANNING COMMISSION HELD NOVEMBER 17, 1959

THE CITY PLANNING COMMISSION MET IN SPECIAL SESSION ON NOVEMBER 17, 1959, AT 8:00 0°CLOCK P.M.

THE MEETING WAS CALLED TO ORDER BY CHAIRMAN STANHURST. PRESENT WERE ARCHIE McVay, Gordon Olsen, John Molino, Alden Loring, O. D. ARP and H. E. Echols.

THE MINUTES OF THE REGULAR MEETING HELD ON NOVEMBER 3, 1959, WERE READ AND APPROVED. THE COUNCIL MINUTES WERE NOTED.

A PETITION FROM THE B.P.O.E. WAS PRESENTED WHICH REQUESTED THE VACATION OF AN ALLEY IN BLOCK 3. A MOTION WAS MADE BY MR. OLSEN AND SECONDED BY MR. LORING THAT THE PETITION BE ACCEPTED AND A HEARING BE CALLED FOR THE VACATION OF THE ALLEY. MOTION CARRIED UNANIMOUSLY.

THE OWNERSHIP OF A TWENTY FOOT STRIP OF LAND ALONG AZALEA PARK MANOR WAS DISCUSSED. MR. ECHOLS WAS INSTRUCTED TO INVESTIGATE THE STATUS OF THIS STRIP. A SIMILAR TWENTY-FIVE FOOT STRIP ALONG RAILROAD STREET WAS DISCUSSED. MR. ECHOLS WAS ALSO INSTRUCTED TO CHECK ON THE OWNERSHIP OF THIS STRIP.

REZONING OF LOTS 5, 6 AND 7 OF THE WOODLAND PARK ADDITION WAS DISCUSSED. A MOTION WAS MADE BY MR. OLSEN AND SECONDED BY MR. LORING THAT A RECOMMENDATION BE MADE TO REZONE LOTS 3, 4, 5, 6 AND 7 FROM M-1 AND R-2 TO C-2.

MR. ARP INFORMED THE COMMISSION THAT HE HAD CONTACTED MR. BAIRD AND THAT MR. BAIRD WAS NOT AGREEABLE TO GIVING FIVE FEET OF LAND ALONG HIS PROPERTY TO THE CITY FOR THE WIDENING OF COVE ROAD.

Subdividing was discussed. The secretary was instructed to request speciman ordinances from the League of Oregon Cities for consideration in adopting an ordinance for the Cmy of Brookings.

A MOTION WAS MADE BY MR. MOLINO AND SECONDED BY MR. OLSEN THAT THE MEETING BE ADJOURNED.
