

MINUTES OF SPECIAL MEETING
OF THE CITY PLANNING COMMISSION

HELD MARCH 15, 1960

THE BROOKINGS PLANNING COMMISSION MET IN SPECIAL SESSION MARCH 15, 1960, AT 8:00 O'CLOCK P.M.

THE MEETING WAS CALLED TO ORDER BY CHAIRMAN STANHURST. PRESENT WERE ALDEN LORING, GORDON OLSEN, JOHN MOLINO, ARCHIE McVAY AND DON HORTON.

THE MINUTES OF THE REGULAR MEETING HELD ON MARCH 1, 1960, WERE READ AND APPROVED.

DON HORTON PRESENTED PLANS ON THE LAUNDROMAT TO BE BUILT IN NORTH BROOKINGS. A MOTION WAS MADE BY GORDON OLSEN AND SECONDED BY JOHN MOLINO THAT THE PLANS BE ACCEPTED AND THE BUILDING INSPECTOR BE AUTHORIZED TO ISSUE A BUILDING PERMIT FOR THE LAUNDROMAT. MOTION CARRIED UNANIMOUSLY.

PLANS ON AN ADDITION TO THE AZALEA LANES BOWLING ALLEY WERE PRESENTED. A MOTION WAS MADE BY MR. LORING AND SECONDED BY MR. OLSEN THAT THE PLANS BE ACCEPTED AND THE BUILDING INSPECTOR BE AUTHORIZED TO ISSUE A BUILDING PERMIT FOR THIS ADDITION. MOTION CARRIED UNANIMOUSLY.

A LETTER FROM THE CITY RECORDER CONFIRMING APPOINTMENTS TO THE PLANNING COMMISSION WAS READ.

THE COUNCIL MINUTES WERE NOTED.

MR. OLSEN PRESENTED A PROPOSED SUBDIVISION ORDINANCE FOR THE CONSIDERATION OF THE OTHER MEMBERS OF THE COMMISSION. THE MATTER WAS TABLED FOR STUDY OF THE ORDINANCE BY THE OTHER MEMBERS OF THE COMMISSION.

OBSTRUCTION OF THE SIDEWALKS BY SEVERAL BUSINESSES WAS DISCUSSED. A MOTION WAS MADE BY MR. MOLINO AND SECONDED BY MR. OLSEN THAT A RECOMMENDATION BE GIVEN TO THE COUNCIL ADVISING THEM OF THIS CONDITION AND REQUESTING THAT THEY TAKE THE NECESSARY PROCEDURE TO ENFORCE ORDINANCE No. 10, SECTION 13 TO REMEDY THIS SITUATION. MOTION CARRIED UNANIMOUSLY.

A MOTION WAS MADE BY MR. LORING AND SECONDED BY ARCHIE McVAY THAT THE MEETING BE ADJOURNED.
