

MINUTES OF
PLANNING COMMISSION MEETING

APRIL 18, 1961

MEETING CALLED TO ORDER BY CHAIRMAN ROBERT STANHURST PRESIDING AT 8:00 P.M.
MEMBERS PRESENT WERE: JACK HOLTE, JOHN MOLINO, ARCHIE McVAY, VIRGIL
GOLDSBERRY, ED OAR, AL PHILLIPS, MAYOR CAMPBELL AND DARREL SWATZEL.

MINUTES OF APRIL 4, 1961, WERE READ AND APPROVED.

THE PROBLEM OF THE LOCATION OF THE PROPOSED ROLLER SKATING RINK WAS REMOVED
FROM THE TABLE AND PLACED ON THE FLOOR BY CHAIRMAN ROBERT STANHURST.

MR. SPILLANE PRESENTED A PETITION ~~TO~~ THE COMMISSION PROTESTING THE BUILDING
OF A ROLLER SKATING BUILDING ON THE PROPERTY LYING SOUTH OF AND ADJOINING THE
DAIRY QUEEN DRIVE-IN.

AFTER MUCH DISCUSSION COMMISSIONER GOLDSBERRY MOVED THAT BADGER & MUSSER
RE-SUBMIT THEIR PLANS WITH A DIFFERENT LOCATION IN THE PLANS.

SECOND BY COMMISSIONER JACK HOLTE. THE MOTION WAS THEN OPENED TO DISCUSSION
AND QUESTIONS AND ANSWER. MR. EBBINGER SPOKE IN FAVOR OF THE PETITION AND
GAVE A BRIEF OUTLINE OF WHY THE PERMIT SHOULD BE TURNED DOWN. QUESTION WAS
CALLED AND THE MOTION CARRIED.

JOHN EBBINGER ASKED THE COMMISSION TO STUDY THE PLANS FOR THE EXTENSION OF
PIONEER ROAD NORTH FROM THE HASSETT INTERSECTION TO THE NORTHERN CITY LIMITS.
THIS WAS PRESENTED IN THE INTEREST OF DEVELOPING THE I O O F CEMETERY.
AFTER A DETAIL EXPLANATION OF WHAT THE CEMETERY BOARD WANTED COMMISSIONER
HOLTE MOVED, THAT, THE COMMISSION RECOMMEND TO THE CITY COUNCIL THAT THE
CITY COUNCIL DESIGNATE THE EXTENSION OF PIONEER ROAD TO THE NORTHERLY
BOUNDARY OF THE CITY LIMITS OF THE CITY OF BROOKINGS, OREGON AND THE EXTENSION
OF MEADOW LANE TO INTERSECT WITH PIONEER ROAD. MOTION SECONDED BY COMMISSIONER
GOLDSBERRY. MOTION CARRIED.

MOTION BY COMMISSIONER McVAY THAT THE CITY COUNCIL TAKE SOME ACTION ON THE
GIVING OF COURTESY PARKING TICKETS TO TOURIST WHEN STOPPING WITHIN THE PARKING
METER AREA. ESPECIALLY THOSE THAT ARE FROM OUT OF STATE. SECONDED BY JOHN MOLINO.
