

MINUTES OF REGULAR MEETING

CITY PLANNING COMMISSION

FEBRUARY 21, 1961

MEETING CALLED TO ORDER BY CHAIRMAN ROBERT STANHURST, PRESIDING AT 8:00 O'CLOCK P.M.

COMMISSIONERS PRESENT WERE VIRGIL GOLDSBERRY, JOHN MOLINO, ARCHIE McVAY, JACK HOLTE,; COUNCILMEN PRESENT WERE ROBERT DIMMICK, ERNEST CHRISTENSEN; *Al Phillips*, OTHERS PRESENT WERE REPORTER MARJ BARRETT, CITY ADMINISTRATOR DARRELL SWATZEL, DOUGLAS PETERSON, MRS. HARRIS, DOYLE RAUSCH, AND GARY WIMBERLY.

MINUTES OF THE MEETING OF JANUARY 21, 1961 WERE READ AND APPROVED, ~~XXXXXX~~. COUNCILMAN CHRISTENSEN GAVE A REPORT ON THE ACTION THE CITY COUNCIL HAD TAKEN IN DRAWING UP AN ORDINANCE CREATING A RECREATIONAL AND PARKS BOARD.

A DISCUSSION ON SELECTING OF A CITIZENS ADVISORY COMMITTEE TO THE COUNCIL IN PLANNING FOR THE FUTURE FOLLOWED. DOUG PETERSEN REPORTED THAT THE J.C.'S AND OTHER ORGANIZATIONS HAD SELECTED A MEMBER OF THEIR GROUPS TO SERVE ON THE COMMITTEE WHEN IT WAS READY TO FUNCTION.

COMMISSIONER McVAY SUGGESTED THAT WHEN THE RECREATIONAL & PARKS BOARD WAS APPOINTED THAT ONE OF THE MEMBERS SHOULD BE APPOINTED TO SERVE ON THE COUNTY PARK BOARD.

THE SECRETARY WAS INSTRUCTED TO CONTACT LEO SHURLIFF OR ROLLO SHARP AND FIND OUT WHAT WAS BEING DONE ABOUT CITY PARKS IF ANYTHING IN CONNECTION WITH THE COUNTY PROGRAM.

THE PROPOSED REVISION OF THE TRAILER PARKING ORDINANCE WAS DISCUSSED BY THE COMMISSION. THE FOLLOWING COMMISSIONERS WERE APPOINTED TO DRAW UP A REVISED CITY ORDINANCE, SETTING FORTH THE FEATURES DESIRED. JACK HOLTE, CHAIRMAN; AND AL PHILLIPS AND VIRGIL GOLDSBERRY.

MOTION BY McVAY THAT THE MEETING BE ADJOURNED, SECONDED BY JOHN MOLINO. MOTION CARRIED. MEETING ADJOURNED AT 9:55 P.M.
