

MINUTES OF REGULAR MEETING

CITY PLANNING COMMISSION

MARCH 7, 1961

MEETING CALLED TO ORDER AT 8:00 P.M. CHAIRMAN JOHN MOLINO, PRESIDING.

OTHERS PRESENT WERE CITY ADMINISTRATOR, DARRELL SWATZEL, ROLLO SHARP, CLIFF McCABE, AND LEO SHURTLIFF OF THE COUNTY PARKS & RECREATIONAL BOARD; MRS. ROLLO SHARP, DON HORTON, GARY WIMBERLY, AND JACK FITZGERALD.

MINUTES OF FEBRUARY 7, 1961 AND FEBRUARY 21, 1961 WERE READ AND APPROVED. MINUTES OF THE CITY COUNCIL MEETING FOR FEBRUARY 14, ~~#~~, 1961 WAS READ FOR THE BENEFIT OF THE MEMBERS OF THE PLANNING COMMISSION.

DON HORTON PRESENT THE BUILDING PLANS FOR THE CATHOLIC CHURCH AND SCHOOL TO BE ERECTED ON A BUILDING SITE SOUTH OF AND EAST OF MARINA DRIVE AND OLD COUNTY ROAD. MOTION BY VIRGIL GOLDSBERRY, SECONDED BY ROBERT STANHURST THAT THE PLANS BE APPROVED AND PRESENTED TO THE CITY COUNCIL. MOTION CARRIED.

ROLLO SHARP WAS INVITED TO GIVE HIS VIEWS ON COUNTY PARKS AND RECREATIONAL FACILITIES THAT WERE BEING PLANNED AND HOW THEY WOULD FIT IN WITH THE CITY OF BROOKINGS PLANS.


SECRETARY CAVENS READ THE LEGAL BASES OF ORS 275.320 TO 275.350 TO THE MEMBERS OF THE PLANNING COMMISSION. IT WAS POINTED OUT BY CLIFF McCABE THAT THE PARKS COMMISSION COULD DEVELOPE PLAYGROUNDS AND PARKS WITHIN THE CORPORATE LIMITS OF A CITY PROVIDING THE CITY GAVE THEM PERMISSION TO DO SO.

PARK BOARD MEMBERS, LEO SHURTLIFF, CLIFF McCABE, AND ROLLO SHARP WERE UNANIMOUS IN THEIR WILLINGNESS TO WORK WITH THE PEOPLE OF THE CITY OF BROOKINGS IN HELPING TO PLAN AND DEVELOPE A CITY-COUNTY PARK.

THE COMMISSION WAS ASKED BY ROLLO SHARP IF THE CITY OR THE STATE HIGHWAY DEPARTMENT FURNISHED A CHURCH DIRECTORY TO BE PLACED ON THE HIGHWAY DIRECTING PEOPLE TO THE VARIOUS CHURCHES. THE SECRETARY WAS INSTRUCTED TO WRITE THE HIGHWAY DEPARTMENT AND FIND OUT WHAT PROCEDURE TO FOLLOW.

THE PROPOSED MODIFICATION OF THE PRESENT CITY ORDINANCE WAS DISCUSSED AT LENGTH. MANY SUGGESTIONS WAS MADE TO THE COMMITTEE. MANY POINTS REGARDING THE LEGAL TECHNALITIES, AND PROBLEMS, WERE POINTED OUT.

MOTION BY JACK HOLTE, SECONDED BY AL PHILLIPS THAT THE MEETING BE ADJOURNED. MOTION CARRIED. MEETING ADJOURNED AT 10:20 P.M.
