

MINUTES OF REGULAR MEETING

CITY PLANNING COMMISSION

APRIL 4, 1961

MEETING CALLED TO ORDER AT 8:00 P.M., CHAIRMAN ROBERT STANHURST PRESIDING.

A PLAT FOR THE SUB-DIVISION OF THE STAFFORD-MAYS PROPERTY LYING NORTH AND WEST OF PARK VIEW DRIVE WAS PRESENTED AND APPROVED BY THE COMMISSION.

PLANS FOR A ROLLER SKATING RINK WAS PRESENTED BY MR. HOAGLAND FOR BADGER & MUSSER. AFTER MUCH DISCUSSION BOTH FOR AND AGAINST THE LOCATION OF THE BUILDING A MOTION WAS MADE BY ARCHIE McVAY THAT THE PLANS FOR THE ERECTION OF THE ROLLER RINK BUILDING BE TABLED UNTIL FURTHER STUDY ON THE ~~PROPOSED~~ PROPOSED LOCATION OF THE BUILDING COULD BE MADE, AND THAT THE PLANS BE DISCUSSED AT A SPECIAL MEETING TO BE HELD TUESDAY, APRIL 21, 1961.
